2. [] [] HIRED NOVEMBER 1948, HAS PRODUCED AS SUB-SOURCES:
() (DISCUSSED PARA 3 BELOW), () (NOW VENEZUELA), () (OF NO INTEREST),
MARCO DE PACLA (DEEMED OF NO INTEREST, COVERED IN REPORT NOW BEING POUCHED).
() HAS REPORTED POLITICAL, CE, MAINLY QUESTURA INSIDE INFO, TOTALING 54 FIELD
REPORTS, 2 DISSEMS. PAID 50,000 LIRE PLUS SMALL EXPENSES MONTHLY. BY FORGING
() SIGNATURE, MISAPPROPRIATED 50,000 LIRE TERMINATION BONUS FOR () ALSO
LIKELY HAS HELD BACK CERTAIN () REPORTS FROM () STILL ON PAYROLL.

MSI MEMBER, LATER PCI GENOA MEMBER COVERING PCI ACTIVITIES. REPORTED BY
[] [] AND [] [] AS PCI AGENT FEEDING DECEPTION MATERIAL AND DISCOVERING
AIS INTERESTS. JULY 1950 TERMINATION HELD UP BECAUSE () STEALING BONUS AND
HOLDING BACK REPORTS. HAS SUBMITTED 107 FIELD REPORTS, 8 DISSEMS. RECEIVED
25,000 LIRE PLUS SMALL EXPENSES MONTHLY. SINCE TERMINATION HAS WORKED DIRECTLY
WITH () RECONSTRUCTING HELD BACK REPORTS AND HAS PROPOSED OPERATION WITH
LUCIANO LARocca COSTING 500,000 LIRE MONTHLY WHICH DEEMED OF NO INTEREST.

5. OCCASIONAL UNPAID SOURCE, HAS RECENTLY PROPOSED OPERATION RE ILLEGAL EMIGRATION GENOA-U.S.

6. OTHER UNPAID OCCASIONAL SOURCES,
 DEVILFISH, KNOWN BY SINCE 1945-1947. SMALL AMOUNT AND LOW QUALITY PRODUCTION DO NOT WARRANT FURTHER INTEREST.

7. ON BASIS ABOVE RECOMMEND FOLLOWING:

A. EARLIEST RETURN HQS.

B. DISCONTINUANCE ALL SOURCES EXCEPT AND

C. ROE SHOULD CONTINUE CONTACT UNTIL DEPARTURE.

REPLACEMENT SHOULD BE INTRODUCED BY AS LATTER'S REPRESENTATIVE.

D. SHOULD BE CONSULTED RE AVAILABILITY LOCAL AMERICAN AS CUT-OUT WILL HAVE TO ARRANGE METHOD PASSING TO NEW CONTROL. NOTE THAT EMPLOYED GENOA IMMIGRATION POLICE.

8. SUGGEST GIVE THOUGHT REPLACING WITH WOULD BLOW COVER BUILT UP DURING PAST YEAR, BUT HE SEEMS MOST LIKELY QUALIFIED MAN AVAILABLE THIS POTENTIALLY IMPORTANT POSITION. ANY REPLACEMENT MUST NECESSARILY HAVE LOOSE COVER, E.G. STUDENT, SINCE WILL AUTOMATICALLY BE BLOWN ITALIANS.
