EMIL A. KEKICH, FSSO, HAS BEEN ASSIGNED TO A NEW POSITION OF CONSULAR ATTACHE CREATED AT THE CONSULATE GENERAL AT ZURICH. UNDER THE SUPERVISION OF THE MINISTER AT BERN AND THE CONSUL GENERAL AT ZURICH, MR. KEKICH WILL BE RESPONSIBLE FOR THE COLLECTING, COLLATING AND FORWARDING TO THE DEPARTMENT, THE DEPARTMENT OF COMMERCE AND OTHER INTERESTED AGENCIES, TOGETHER WITH COMMENTS OR CONCLUSIONS, ALL COMMERCIAL, FINANCIAL AND OTHER ECONOMIC DATA WHICH MAY BECOME AVAILABLE AT THIS POST RELATIVE TO THE FOLLOWING COUNTRIES:

ALBANIA	POLAND
BULGARIA	RUMANIA
CZECHOSLOVAKIA	YUGOSLAVIA
HUNGARY	SOVIET UNION

MR. KEKICH'S DUTIES WILL INCLUDE CONTACT WITH TRAVELERS FROM EASTERN EUROPEAN COUNTRIES, AND ADDRESSEE POSTS SHOULD FURNISH TO HIM INFORMATION ON COMMERCIAL TRAVELERS AND OTHERS WHO MAY VISIT SWITZERLAND AND MAY HAVE INFORMATION OF VALUE, TOGETHER WITH COPIES OF REPORTS ON EASTERN EUROPEAN ECONOMIC MATTERS PREPARED BY THEM AND ALL OTHER INFORMATION AND SUGGESTIONS WHICH MAY AID IN THE GATHERING OF ECONOMIC INFORMATION AND DATA ON EASTERN EUROPE AT THIS POST.
