1. REQUEST YOU DETERMINE SOONEST FEASIBILITY SENDING REPRESENTATIVE BRITISH ZONE GERMANY TO INTERVIEW HELMUTH WOHLTAT, GERMAN NATIONAL, TO DETERMINE IF NICOLAW MALAXA, CURRENT RUMANIAN EMIGRE INDUSTRIALIST, REPRESENTED RUMANIA IN DEALING WITH WOHLTAT TO CONCLUDE RUMANIAN GERMAN ECONOMIC AGREEMENT 1939.

2. MOST IMPORTANT YOU NOT FRIGHTEN WOHLTAT INTO BELIEVING WE ATTEMPTING OBTAIN EVIDENCE RE HIS, WOHLTAT, PAST ACTIVITY. YOU MAY TELL HIM WE KNOW HE WAS IN CHARGE ECONOMIC NEGOTIATIONS BETWEEN RUMANIA AND GERMANY 1939 AND THIS NO CONCERN TO US. WE ONLY ATTEMPTING ESTABLISH IDENTITY MEMBERS RUMANIAN ECONOMIC MISSION TO GERMANY AT THAT TIME.

3. IF INTERVIEW GOES WELL HQ WOULD LIKE WRITTEN STATEMENT FROM WOHLTAT CONCERNING MALAXA PART IN NEGOTIATIONS.

4. FOR YOUR INFO ONLY: MALAXA CURRENTLY BEING CONSIDERED AS PERMANENT IMMIGRANT IN U.S. HE STATED HE DID NOT GO GERMANY AS MEMBER RUMANIAN ECONOMIC MISSION 1939 TO MAKE DEAL WITH WOHLTAT WHILE DYCLAIM INFORMANTS STATE HE WAS MEMBER SUCH MISSION. WE ATTEMPTING DETERMINE TRUTH THIS MATTER. WOHLTAT ADDRESS FOLLOWS: FIRM 5 ALT PEMPELDORF, DUSSELDORF. HIS BUSINESS ADDRESS IS: HENKEL AND COMPANY, 76 HENKELSTRASSE, DUSSELDORF, HOLTHAUSEN.
