1. WKORANGE/62 WAS RECRUITED IN APRIL 1984 AS A WITTING  
COLLABORATOR WHO WAS TO EFFECT DIRECT [ ] CONTACT WITH THE SOVIET  
AMBASSADOR WITH WHOM HE WAS FRIENDS. HE WAS ADMINISTRATIVELY  
TERMINATED IN JULY 85 SINCE ALTHOUGH O/62 PROVIDED SOME  
INTERESTING COMMENTS REGARDING THE SOVIET AMBASSADOR, HE COULD  
NEVER EFFECT DIRECT CONTACT BETWEEN THE [ ] AND THE SOVIET  
AMBASSADOR OR ANY OTHER SOVIET TARGETS. CONSEQUENTLY, BASED ON  
LACK OF PROGRESS, [ ] CONTACT WAS DROPPED WITH THE PCS  
DEPARTURE OF THE [ ] IN JULY 1985. NO TURNOVER OF THE ASSET WAS  
MADE AND [ ] HAD NO PLANS TO RECONTACT HIM.

2. A WEALTHY BUSINESSMAN, O/62 DID NOT RECEIVE A SALARY.  
HE WAS MOTIVATED BY A WILLINGNESS TO COOPERATE WITH THE [ ]  
THERE WERE NO FORMAL COMMITMENTS IN THIS RELATIONSHIP.
