Source affirms categorically that Petre CONSTANTINESCU, alias Nicolae BOGDAN, alias Titi, residing in Salzburg, Auerspergstrasse 25/II, has been in the service of the Yugoslavs for about the last one and one-half years and that he (CONSTANTINESCU) had undertaken a trip to Belgrade in August 1952.</p> <p>12. Presently, CONSTANTINESCU's only source of income is from the Yugoslavs.</p> <p>13. Among CONSTANTINESCU's principal collaborators in the Salzburg area is one MARGARIT, alias Johann STANESCU, residing in Salzkammergut, Strobl 14. MARGARIT is living with an Austrian leftist Socialist, who helps him make certain contacts and connections.</p> <p>14. MARGARIT has been making (recently) many trips to Innsbruck, where Petre CONSTANTINESCU has a friend with whom he is involved in intelligence work; he is one Dr. GOSNER, originally from the village of Liebling in Jud. Timis Torontal, and whose parents are now in Ciacova, the same Judet.</p> <p>15. For the past several weeks CONSTANTINESCU has been attempting to obtain a visa for entering France, through the French Consulate in Innsbruck.</p> <p>...."</p>
