1. CASE OFFICER HAS BEEN CONVINCED THAT IMPLEMENTATION MATVIYEVKOBAN TOO EXPENSIVE IN TERMS OF THE SECURITY, DISPOSAL, JUDICIAL AND CROSS-AGENCY PROBLEMS WE WOULD INHERIT.

2. MY VIEW IS THAT OUN/B COMPLEX REPRESENTS; AT THIS TIME, NONE OF A DEFENSIVE PROBLEM RE OUR OTHER OPERATIONS THAN AN OFFENSIVE ONE OF EXPLOITING POSITIVE LEADS BE THEY TO POLAND OR THE UKRAINE. BANDERA'S SUCCESS OVER PAST FOUR YEARS IN BEFUDDLING AMZON AGENCIES SHOULD BE OF INCREASING CONCERN TO THE THEATER. SHORT OF IMPOSITION OF POSITIVE CONTROLS OVER BANDERA HIMSELF, NO SINGLE CONTACT WITHOUT OUN/B CAN BE RELIED ON. AN INESCAPABLE ASSUMPTION REGARDING THE COMPLEX IS THAT, GIVEN ITS CONTINUING AND UNCENSORED ACTIVISM, RIS:HAS AT HAND AN EMINENTLY SUITABLE ENGINE FOR ITS OWN OPERATION IN AMZON AND WESTERN EUROPE.

3. SUGGEST THAT [ ] AND I DISCUSS THE PROBLEM IN AN EFFORT TO RESOLVE UPON A POSITIVE PLAN WHICH COULD POINT UP THE SERIOUSNESS OF THE SITUATION TO RESPONSIBLE INTELL AGENCIES IN AMZON. IN SHORT, A THOROUGH GOING CI JOB MUST BE DONE TO SERVE OUR IMMEDIATE PURPOSES:

A. COVER AN UNGUARDED OPERATIONAL FLANK RE OUR SOVIET/UKRAINE
