1. OBVIOUSLY McCARGAR, WHILE PROFESSING TO BE PROFESSIONAL INTELLIGENCE OFFICER, BY HIS ATTITUDE DEMONSTRATES HE HAS NO CONCEPT OF BASIC RESPONSIBILITIES INTELLIGENCE OFFICER. IF ALL OF THE THINGS HE TALKS ABOUT IN THE BOOK WERE BELIEVED BY HIM, HE WOULD NOT DREAM OF PUBLISHING THIS DOCUMENT.
2. YOU MAY ASSURE HIM WE WILL DO EVERYTHING POSSIBLE TO LEGALLY PREVENT THE BOOK. ABOVE IS FROM LADSON AND YOU CAN QUOTE HIM TO McCARGAR BY NAME IF YOU WISH OR THINK IT WOULD BE USEFUL.
3. IN THE MEANTIME, AND FOR YOUR OWN GUIDANCE, WE ARE NOT VERY OPTIMISTIC ABOUT ANY POSSIBILITIES OF LEGAL ACTION, AND RECOGNIZE THAT EVEN IF WE DID SUCCEED IN SUPPRESSING IT IN THE US, HE UNDOUBTEDLY COULD GET IT PUBLISHED IN BRITAIN, FRANCE, GERMANY, OR CONCEIVABLY COULD SELL IT TO THE SOVIETS. WE RECOGNIZE THAT AT THE MOMENT HE IS DESPERATE AND WILL GO FOR
