1. REF DISCUSSED 7 JULY WITH MCCARGAR WHO IS WRITING HIS PUBLISHERS TODAY AUTHORIZING FULL COOPERATION WITH AGENCY ON FOLLOWING BASIS:

A. KUBARK SHOULD PRESENT ITS REQUEST FOR AMENDMENTS OR DELETIONS WITHOUT DELAY SINCE PRINTING OF BOOK SCHEDULED TO BEGIN ON 1 AUG.

B. ONCE PRINTING HAS BEGUN, ANY SUBSEQUENT CHANGES OR DELETIONS REQUESTED BY KUBARK, IF AGREED UPON, WOULD BE AT AGENCY EXPENSE, OTHERWISE PUBLISHERS WOULD CHARGE THIS DIRECTLY TO MCCARGAR.

C. ANY CHANGES AGREED UPON WITH PUBLISHERS MUST BE APPROVED BY MCCARGAR.

2. MCCARGAR FEELS THIS DEADLINE IS REASONABLE IN VIEW OF FACT MANUSCRIPT HAS BEEN IN AGENCY'S HANDS FOR THREE MONTHS, THUS PROVIDING AGENCY AMPLE TIME PREPARE ITS REQUESTS FOR MODIFICATIONS.

3. APPRECIATE AGENCY FORWARD COPY OF ITS REQUESTS FOR CHANGES TO [] SOONEST IN ORDER WE MAY BE IN ADVANTAGEOUS POSITION TO RESPOND TO ANY COMMENTS MCCARGAR MAY HAVE ON THEM.
