REQUEST IMMEDIATE CONTACT WITH JAMES MCCARGER TO ASK HIM TO INSIST THAT BRITISH PUBLISHERS, SECKER AND WARBURG, DO NOT IN THEIR PROMOTIONAL ADVERTISING LINK MCCARGER OR IDENTIFY HIM IN ANY WAY WITH KUBARK. CARL BRANDT, AGENT FOR MCCARGER, SAYS IT HIS UNDERSTANDING SECKER AND WARBURG WILL COMPLY WITH MCCARGER'S WISHES REGARDING BOOK. DUTTON AND CO. HAD INFORMED KUBARK THAT AMERICAN AND BRITISH PUBLISHERS ARE USING SAME MANUSCRIPT, NEW YORK FIRM DOING AN OFFSET OF BRITISH PUBLICATION. URGENT THAT MCCARGER TAKE IMMEDIATE ACTION. PLEASE ADVISE MCCARGER THAT WE HAVE FAR FROM EXHAUSTED THE COURSES OF ACTION IN THIS REGARD. ADVISE US PROMPTLY OF HIS ATTITUDE.
