1. We have run RI traces on Subject's associates with the following results.

- a. Frits LEITHE no information on Subject not known to you.
- b. Ludwig Sebastian MAIR no information on Subject not known to you.
- c. Frau Christa BUJAR. No identifiable traces.
- d. Frits KOSMUTZKI. No additional traces.
- e. Dr. Paul Rheinlaender. Mentioned as being active in building up German/Spanish trade in 1953, and as head of the Salsgitter firm. Attachment A is a bio sheet on him.

2. We have searched RI with negative results for a meaningful identification of fnu GERSHEVICH and reasonable variants. We are forwarding a biographic sketch (Att. B) on one Nikolay Aleksyevich GERSHEVICH, who, according to an old defector debriefing as of 1949 was still an MVD Colonel, but who could conceivably over the years have been released from military type duty and reassigned to a Moscow Ministry. REDWOOD material contains no further identifying data on "GIPROCASTROPROM" or the Moscow telephone number V3-00-02. KUPALM files indicate that one I. GERSHEKOVICH has published articles on Limits of the Planned Wage Fund, while assigned to Production Standards in the Electric Industries and in 1959 he published a daily chart at the Moscow Electro-Mechanical Factory Im. Vladimira Ili'icha.
