Paragraph 1 contains a brief but complete synopsis of the case, its source and evaluation, and the reason for the investigation.
Paragraph 2 contains specific and detailed instructions on what is desired to complete the case.

1. Your report concerning the subject and his contact with the Schevtschenko Association was forwarded to TUCON and they have forwarded us the following additional info concerning him known to them, obtained from other than CIA sources:

a. Former address of MENDE was BERLIN W5, Friedrich Wilhelm Str. 10. Was head of German Committee on Turkoman Affairs in 1941. In August 41 was in Turkey with Brigadefuhrer ZIMMERMAN (see dossier for further extract of his background)

b. MENDE is allegedly a lecturer at University of HAMBURG at present. He is suspected of maintaining connection with Caucasian immigrant groups on behalf of British intelligence. In Sep 46 he contacted several important personalities from these groups to discuss anti-Bolshevist propaganda and obtain info from the Caucasian area. These personalities were: DARI (Turkestanian); ERISLILI (Crimean Tartar); Mustafa ALI (Caucasian); Prince Michael ALIASHVILI (Georgian). In Jan 47 ALIASHVILI and TCHAYVA accompanied von MENDE to a meeting with an unidentified British captain in HAMBURG.

2. Desire additional info concerning MENDE's present activities, associates, the Schevtschenko Association, and any indication that any of above individuals are still in contact with von MENDE.
