14. ISMAIL AKBER [ ] ALSO ADMITTED TO ME DURING THE CONVERSATION THAT HE HAD BEEN ACTIVE FOR PROFESSOR VON MENDE [ ]. HE ALSO SPOKE OF SOME DIFFICULTIES WHICH HAD BEEN OCCASIONED HIM BY AN AZERBAIJANI, AN OLD IMMIGRANT, WHO, BECAUSE OF AKBER'S ANTI-SOVIET ATTITUDE, WANTED TO DENOUNCE HIM TO THE BRITISH AS A FASCIST. HE ALSO MENTIONED A DIFFERENCE OF OPINION WHICH HE HAD HAD WITH DR. V. MENDE CONCERNING HIS BRINGING HIS WIFE, WHOSE PARENTS ARE SAID TO WORK IN THE SOVIET SECTOR OF BERLIN, TO OPERATIONAL MEETINGS. AKBER PROTESTED AGAINST THIS PRACTICE ON THE REQUEST OF HIS COLLEAGUES. AKBER DIDN'T SPEAK VERY MUCH ABOUT V. MENDE. WHEN I ASKED HIM IF V. MENDE KNEW THAT HE WAS GOING TO VISIT ME, HE REPLIED THAT HE DID NOT. SINCE HE EXPECTS TO REMAIN HERE UNTIL AT LEAST THE BEGINNING OF JANUARY, HE GAVE ME HIS DEFINITE PROMISE THAT HE WOULD VISIT ME AGAIN AND BRING ME A LETTER FROM ABASSOW WHO IS IN TURKEY.
