1. A JEWISH GROUP INTERESTED IN INVESTIGATING THE WHEREABOUTS OF NAZI WAR CRIMINAL JOSEPH MENGELE HAS INFORMED THE DEPARTMENT THAT THEY WILL BE VISITING PARAGUAY NOVEMBER 21-24. THEY ARE: ELIZABETH HOLTZMAN, NEW YORK DISTRICT ATTORNEY AND FORMER MEMBER OF CONGRESS; BEATE KLARSFELD, WELL KNOWN NAZI WAR CRIMINAL HUNTER; AND MENACHEM Z. ROSENSAFT, CHAIRMAN OF THE INTERNATIONAL NETWORK OF CHILDREN OF THE HOLOCAUST SURVIVORS.

2. THE DEPARTMENT WOULD APPRECIATE EMBASSY'S EXTENDING THEM APPROPRIATE COURTESIES AND ASSISTANCE DURING THEIR STAY IN PARAGUAY. SHULTZ
