1. An extensive search of the files and indices of this Directorate surfaced the following information concerning the alleged aliases of Joseph Mengele. (C)

2. According to DONC-00047/79 dated 1 October 1979, a trace request from the Special Assistant for Coordination of Foreign Narcotics Information to the Drug Enforcement Administration and U.S. Customs Service, Joseph Mengele had used the following aliases: Fausto Rindon, Jose Aspiazi, Ernst Sebastian Alvez, Walter Hasek, Heinz Stobart, Karl Geuske, and Lars Ballstroem. He also used the aliases Dr. Helmut Gregor-Gregori and Friedrich Edler von Breitenbach while in Buenos Aires, Argentina, and Dr. Fritz Fischer and Dr. Henrique Wollman while in Encarnacion, Paraguay. (S)

3. According to CSDB-312/03767-72 dated 26 September 1972, one Dr. Henrique Wollman was a partner of fnu Becker and Enio Varela on a farm near Asuncion, Paraguay. Becker and Varela were arrested in late 1970 for attempting to smuggle narcotics into the U.S. Dr. Wollman also owned two other farms in Paraguay and resided in Encarnacion, Paraguay. (S)

4. According to DIR-290085 dated 15 July 1972, Mengele resided in Encarnacion, Paraguay, and used Henrique Wollman. The report suggested that he was involved in narcotics trafficking. (S)

According to information provided to this Directorate by DDA/IPD dated 15 January 1985, there is no indication that Joseph Mengele or Helmut Gregor-Gregori, Fausto Rindon, Jose Aspiazi, Ernst Sebastian Alvez, Friedrich Edler von Breitenbach, Walter Hasek, Heinz Stobert, Karl Geuske, Fritz Fischer, Lar Ballstroem, or Henrique (Enrique) Wollman, has ever been the subject of an FOIA/PA request. (C)
