1. STATION HAS HELD DISCUSSIONS WITH COM REGARDING THE TRACKING DOWN OF SUBJECT. WE ARE IN AGREEMENT THAT PVALUE WILL, FOR THE MOMENT, BE TASKED WITH PRIMARY RESPONSIBILITY FOR CHECKING OUT LEADS TO MENGELE. COM WANTED TO KNOW IF STATION HAS SOMEONE CAPABLE OF UNDERTAKING THIS TASK - DISCREETLY - AND COS HAS RESPONDED POSITIVELY (WITHOUT PROVIDING DETAILS). (PER PREVIOUS TRAFFIC) IS ALREADY CHECKING OUT LEADS. BELIEVE THAT IS IDEALLY SUITED FOR THE TASK AND IF NEED BE (WITH ADDITIONAL FUNDS) COULD RECRUIT ADDITIONAL INVESTIGATORS TO RUN DOWN RUMORS, CALL-INS, ETC., WHICH DUE TO THE POSTED REWARDS ARE ALREADY COMING IN TO THE EMBASSY.
