1. WE COULD ASK [ ] TO USE THE RESOURCES OF THE  
MILITARY TO LOOK FOR MENGELE, AND WE COULD ALSO USE  
[ ] AND [ ] UNILATERALLY WITHIN  
THE POLICE. OTHERWISE, THE EMBASSY WOULD ALSO GO TO THE  
MILITARY AND THE POLICE OVERTLY.

2. WE HAVE NOT REALLY DISCUSSED THIS WITH THE AMBASSADOR  
AT ANY LENGTH. WE HELPED DRAFT THE EMBASSY'S RESPONSE TO THE  
ROGER CHANNEL MESSAGE, INCLUDING A REMARK TO THE EFFECT THAT  
OUR ROLE WULD BE TO CONDUCT A "PARALLEL INVESTIGATION" THROUGH  
OUR ASSETS IN SUPPORT OF THE JOINT EFFORT. NOBODY HERE REALLY  
THINKS MENGELE MIGHT BE IN BOLIVIA, UNLESS HE IS HIDING OUT  
WITH THE DRUG TRAFFICKERS. IF THAT IS THE CASE, HE WILL BE  
DIFFICULT TO LOCATE INDEED. WE WILL ASK [ ] IF HE HAS  
HEARD ANYTHING ABOUT MENGELE BEING HERE WITH THE TRAFFICKERS.
