1. JUDGING FROM RECENT CONVERSATIONS UP THERE, CAMEN IS ALSO INVOLVED IN THE SEARCH FOR MENGELE. STATION [] LIAISON OFFICER WILL BE AT CAMEN ON 11 APRIL AND WILL CHECK WITH THEM. IF CAMEN IS INVOLVED, WE WILL LEARN DETAILS OF THEIR INVOLVEMENT AND REPORT SAME ON 12 APRIL.

2. WE HAVE NO TRACES ON THE PROSECUTORS NAMED IN PARA THREE OF REF OR THE LAWYER IN PARAS SEVEN AND EIGHT, BUT WILL ALSO FIND OUT MORE ABOUT THEM FROM CAMEN. HORST ((GEMMER)) MENTIONED IN PARA THREE IS NOT WITH CAMEN AS STATED, BUT IS THE CHIEF OF THE DEPARTMENT RESPONSIBLE FOR POLITICAL CRIME (STAATSSCHUTZ) AT THE HESSEN STATE POLICE OFFICE (LKA HESSE) IN WIESBADEN.

3. WE AND [] WILL BE MOST HAPPY TO COOPERATE IN ANY MANNER POSSIBLE IN THIS EFFORT, AND WELCOME MEETING WITH THE LNTONE MARSHALS. MARSHALS SHOULD CONTACT IDEN IN BONN.
