1. LIAISON HAS CONFIRMED THAT THE SUSPECTED "MENTLE" IN URUGUAY, SUBJECT OF REF, WALTER JUAN ((BRANAA)) FACCIO SOUBERVIELLE, NEVER DIED AS REPORTED BY DEA REF IN BUENOS AIRES. (SEE REF PARA 6 ON THIS.) THUS, WE ANTICIPATE THAT THE BRANAA FINGERPRINTS FORWARDED TO FBI PER REF ALSO WILL PROVE NOT TO BE IDENTICAL WITH THOSE OF MENGLER. (A QUICK COMPARISON BY [ ] AND LEGATT OF PRINTS OF BRANAA PROVIDED BY LIAISON AND COPY OF THOSE PROVIDED BY BRANAA TO DCM/LEGATT DURING 17 APRIL INTERVIEW INDICATES THAT PRINTS MATCH. NO DATE AVAILABLE ON LIAISON PRINTS OF BRANAA.) [ ] HAS COPIES OF LIAISON BIO DATA AND PRINTS IF LATER NEEDED. BASED THE ABOVE, THE BRANAA ASSUMED IDENTITY THEORY OF DEA BUENOS AIRES DOES NOT SEEM TO BE VALID.

2. WE TOOK THE STEP WITH LIAISON AFTER RECEIPT OF STATE ROGER CHANNEL BY EMBASSY SAYING THAT WASHINGTON AGENCIES HAD COORDINATED AND DECIDED THAT [ ] SHOULD QUERY LIAISON AND SEEK ANY AVAILABLE INFO FROM LIAISON RE MENGLER OR SUSPECT MENGELE(S).
