1. [] []: NEXT VISIT TO CAMEN IS SCHEDULED FOR 15 MAY. AS AL MATNEY WILL BE IN GERMANY UNTIL 17 MAY, WE BELIEVE THE BEST COURSE OF ACTION WOULD BE FOR DALAIMER TO TAKE HIM TO CAMEN AND DISCUSS TH MATTER WITH CADOME/6 (D/6). WE HAVE CHECKED WITH D/6 AND HE WILL BE AVAILABLE THAT DAY. HE, TOO, SAID THAT HE DOES NOT BELIEVE MUCH WILL COME OF THE MEETING ON 9 MAY, WHICH WILL ALSO BE ATTENDED BY D/6'S DEPUTY JOHANNES HORN. D/6 SAYS MORE CAN BE ACCOMPLISHED IN SMALLER GROUPS. WE STRESS AGAIN, HOWEVER, THAT CAMEN'S ROLE IN THE MENGELE CASE IS ONE OF ADVICE AND SUPPORT. THE FRANKFURT PROSECUTING ATTORNEY IS IN CHARGE AND HIS INVESTIGATING AGENCY IS THE LKA UNDER GEMMER (NOT HIS BROTHER IN FRANKFURT). NONETHELESS, WE BELIEVE A MEETING WITH D/6 WOULD BE PRODUCTIVE FOR MATNEY.

2. AS FOR DISCUSSION WITH PVALUE CONCERNING THE GERMAN APPROACH, THEIR LIMITATIONS AND CAPABILITIES, WE BELIEVE [] [] CAN COVER ALL OF THIS WITH MATNEY ON 15 MAY. AS YOU KNOW, SGSWIRL IS NOT ALLOWED IN GERMANY, AND THIS IS THE REASON THE MARSHALS WERE TOLD IT WAS OUT OF THE QUESTION. THE GERMANS ARE NOT BEING OBSTINATE; THEY ARE LEGALLY FORBIDDEN TO USE THIS TOOL.

3. [] [] CAN PICK MATNEY UP AT BASE BETWEEN 1030 AND 1100 HOURS ON 15 MAY AND TAKE HIM TO WIESBADEN. IF A MEETING WITH GEMMER HAS NOT BEEN ACCOMPLISHED, [] [] IS ALSO WILLING TO MAKE AN ARRANGEMENT FOR THIS, AS [] [] IS WELL ACQUAINTED WITH GEMMER.

4. PLEASE ADVISE IF THESE ARRANGEMENTS ARE ACCEPTABLE TO MATNEY.
