1. APPEARS THAT MARSHALS HAD THEIR VISIT TO CAMEN THROUGH  
AUSPICES OF THEIR FRANKFURT CONTACTS. "BONNER RUNDSCHAU" OF  
11 MAY CARRIED ARTICLE ON FRONT PAGE WHICH STATES GERMAN, US, AND  
ISRAELI OFFICIALS MET IN FRANKFURT TO DISCUSS TRACKING ((MENGELE)).  
CAMEN ALSO TOOK PART. WE THEN LEARNED FROM CAMEN ON 15 MAY THAT  
THE GROUP HAD ALSO MET AT CAMEN HQS. PERSONS TAKING PART WERE  
THE GERMAN HEAD OF THE MENGELE INVESTIGATION, FRANKFURT PROSECUTOR  
HANS EBERHARD ((KLEIN)), AN INDIVIDUAL FROM HIS OFFICE NAMED  
((HESS)), CHIEF OF THE ISRAELI ATTORNEY-GENERAL'S FOREIGN  
DEPARTMENT ((GULDMANN)), ISRAELI POLICE LT.COL. ((RUSEK)), OF  
THEIR NAZI CRIME OFFICE, AND THE FOLLOWING AMERICANS:

JUSTICE UNDER SECRETARY AND DEPUTY ATTORNEY-GENERAL RICHARDS.  
JUSTICE SPECIAL PROJECTS DIRECTOR SHER.  
ASSISTANT TO SHER, MARVEL.  
US MARSHAL DIRECTOR OF OPS SAFIR.  
ASSISTANT TO SAFIR, FERRARONE.  
ASSISTANT TO SAFIR, STOLZ.

2. ALTHOUGH CAMEN AND CAWHISPER HAVE MINUSCULE ROLES IN THIS  
INVESTIGATION, WE STILL BELIEVE IT WOULD HAVE BEEN USEFUL FOR THE  
US TEAM TO MEET WITH US AND THEN WITH US AND CAMEN TOGETHER, AS WE  
HAD PLANNED. THIS MAY NO LONGER BE NECESSARY NOW THAT THEY HAVE  
HAD DIRECT CONTACT WITH CAMEN AND LEARNED FOR THEMSELVES THAT THE  
PROPER INTERLOCUTORS ARE IN FRANKFURT. NEVERTHELESS, STATION WOULD  
STILL BE HAPPY TO ACCOMMODATE THEM SHOULD THEY REMAIN UNCERTAIN  
ABOUT RELATIVE ROLES AND RESPONSIBILITIES OF FRG AGENCIES IN  
THE MENEGLE INVESTIGATION.
