1. APPRECIATE REF A INITIATIVE. BEFORE PROCEEDING FURTHER, HOWEVER, BELIEVE WE SHOULD DISCUSS IN GREATER DETAIL CERTAIN PITFALLS THAT COULD ARISE IN USE OF PARAGUAYAN OPPOSITION FIGURES SUCH AS [ ] TO CATCH MENGELE. THE OPPOSITION HAS BEEN QUITE FRANK IN TELLING THE US MARSHALL'S SERVICE THAT THE OPPOSITION WILL DO ANYTHING THAT WOULD DISCREDIT OR EMBARRASS THE STROESSNER REGIME. GIVEN THIS BUILT-IN BIAS, IT IS POSSIBLE THAT OPPOSITION SOURCES ON MENGELE COULD TILT THEIR REPORTING ACCORDINGLY. OF CONCERN TO THE EMBASSY IN ASUNCION IS THAT STROESSNER WOULD ERRONEOUSLY EQUATE U.S. EFFORTS TO CATCH MENGELE WITH THE USE OF INFORMATION FROM OPPOSITION SOURCES WITH U.S. SUPPORT FOR OPPOSITION EFFORTS DIRECTED AGAINST STROESSNER. OBVIOUSLY THIS IS NONSENSE TO US BUT COULD BE INTERPRETED AS REALITY BY STROESSNER. FOR THIS REASON THE EMBASSY IS TREADING CAUTIOUSLY WITH REGARD TO THE USE OF OPPOSITION SOURCES. WE WILL GET A BETTER READING ON THE EMBASSY'S FINAL POSITION ON THE ISSUE UPON THE RETURN OF THE AMBASSADOR.

2. THE ABOE IS NOT MEANT TO EXCLUDE THE USE OF OPPOSITION SOURCES, PARTICULARLY THOSE WHO WOULD HAVE UNIQUE ACCESS. SUGGEST, HOWEVER, THAT WE FIRST GET REACTION OF AMBASSADOR AND DEPT TO VISIT OF USMS TEAM TO AREA (REF B) BEFORE DISCUSSING WITH USMS THE POSSIBLE USE OF [ ]
