1. APPRECIATE STATIONS' POSITIVE SUPPORT FOR U.S. MARSHALS SERVICE (USMS) DURING THEIR VISITS WITH YOU. HQS WILL MEET WITH THEM UPON THEIR RETURN TO FOLLOW UP ON SPECIFICS DISCUSSED AND FORWARD LEADS ON MENGELE CASE DEVELOPED BY THEM.

2. HQS AGREES THAT ASUNCION NOT APPROPRIATE OPERATIONAL BASE FROM WHICH USMS TO OPERATE EVEN ON TDY BASIS. WE WILL DISCUSS THIS FURTHER WITH USMS.

3. RE POSSIBILITY OF COS [] TRAVELING PERIODICALLY TO THIRD COUNTRY AS SUGGESTED REF B, THIS, OF COURSE, WOULD BE SUBJECT OPERATIONAL NEEDS AT TIME, BUT WE ENDORSE IDEA IN PRINCIPLE.
