1. ON 29 MAY HQS OFFICERS MET WITH U.S. MARSHALS SERVICE (USMS) RE THEIR RECENT TRIP TO YOUR AREA. USMS (MR. DONALD FERRARONE) WAS MOST APPRECIATIVE FOR YOUR SUPPORT DURING THAT TRIP.

2. LAST WEEK USMS MET WITH NVABROAD TO DISCUSS PROPOSAL TO PLACE TWO MARSHALS (ONE OF WHOM WILL BE SPANISH SPEAKER) IN BUENOS AIRES FOR EXTENDED TDY (APPROXIMATELY SIX MONTHS) TO DEVELOP AND RUN INFORMANTS ON AREA WIDE BASIS TO LOCATE MENGELE. USMS IS NOT RPT NOT CONSIDERING PLACING MARSHALS IN ANY OTHER LOCALE. NVABROAD AGREES WITH BASIC PROPOSAL AND WILL BE COMMUNICATING THAT AGREEMENT SHORTLY.

3. IN CONTEXT USMS PRESENCE IN BUENOS AIRES, HQS HAS OFFERED USE OF STATION COMMO TO FACILITATE USMS TRAFFIC. DISCUSSION ALSO FOCUSED ON TWO SPECIFIC QUESTIONS WHICH WERE, ONE, SHOULD NOT USMS TEAM BE DECLARED TO LOCAL SECURITY SERVICES IN BUENOS AIRES SINCE USMS WILL HAVE TO WORK WITH THEM IN COURSE ATTEMPTING LOCATE MENGELE AND, TWO, ADVANTAGES OF USMS TEAM HAVING NOMINAL NVABROAD COVER. LATTER WOULD GIVE THEM EASY ACCESS TO NVENGRAM AND MEET SENSITIVITIES OF HOST GOVERNMENT RE HAVING U.S. LAW ENFORCEMENT PRESENCE ON ITS SOIL. SAME CONSIDERATION WOULD APPLY TO USMS TRAVELING TO OTHER COUNTRIES IN AREA. (NVABROAD CONCURS IN THIS.) REQUEST STATION AND NVENGRAM AGREEMENT ON BOTH POINTS. AS NOTED REF A, USMS EMPHASIZED TDY TEAM WOULD COORDINATE FULLY ITS ACTIVITIES WITH STATION, INCLUDING CHECKING OUT ITS INFORMANTS WITH STATION AND HQS. ALSO, WE ARE ARRANGING FOR USMS TO BRIEF NEW [] COS [] ON SITUATION.

4. [] YOUR REPORT FROM [] WAS GIVEN TO USMS AS A CIOL WHICH IS WAY ALL FURTHER REPORTING ON MENGELE WILL BE HANDLED.

5. PURPOSE OF 3 TO 8 JUNE (WHICH NOW POSTPONED TO 8 JULY) VISIT OF JUSTICE DEPARTMENT TEAM LED BY DEPUTY ASSISTANT ATTORNEY GENERAL MARK RICHARDS TO ARGENTINA, BOLIVIA, PARAGUAY AND URUGUAY IS TO MAKE A FORMAL REQUEST FOR FULL COOPERATION BY THE HOST GOVERNMENTS IN TRYING TO LOCATE MENGELE.
