1. ON 31 MAY, COS WAS INVITED BY [] TO A
FAREWELL LUNCH WHICH WAS FOLLOWED BY A MEETING WITH CHIEF,
[]. THESE MEETINGS PROVIDED A GOOD OPPORTUNITY
FOR COS TO REVIEW PRESENT LIAISON ACTIVITIES AND TO MAKE A PITCH
FOR EXPANDING JOINT ACTIVITIES IN THE FUTURE. AS IN THE PAST,
BOTH [] AND [] EXPRESSED APPRECIATION FOR THE EXISTING
COLLABORATION WITH PVALUE AND LOOKED FORWARD TO OPPORTUNITIES
TO BUILD ON THIS RELATIONSHIP.

2. AS AN EXAMPLE, [] SAID THAT BASED ON HIS PREVIOUS
CONVERSATION WITH COS CONCERNING THE IMPORTANCE OF ASSISTING
IN THE EFFORT TO LOCATE JOSEF MENGELE, [] HAD PREPARED A
MEMORANDUM HIGHLIGHTING THE VALUE FOR ARGENTINA IN HELPING IN
THIS ENDEAVOR. [] WENT ON TO ADD THAT HE HAD STRESSED THAT A
SUCCESSFUL EFFORT WOULD HAVE VERY POSITIVE RESULTS IN IMPROVING
ARGENTINA'S UNFAVORABLE RIGHTIST IMAGE AND ENHANCING THE ALFONSIN
GOVERNMENT'S RELATIONS WITH THE LOCAL JEWISH COMMUNITY. [] WHO
ALSO IS ENTHUSIASTIC ABOUT THIS EFFORT, PRESENTED [] MEMORANDUM
TO PRESIDENT ALFONSIN, WHO AUTHORIZED THE [] TO COOPERATE FULLY
WITH U.S. AUTHORITIES IN THIS ENDEAVOR.

3. ON A DIFFERENT SUBJECT, [] SAID THAT HIS SERVICE ALSO
WAS INTERESTED IN WORKING TOGETHER AGAINST THE NARCOTICS TARGET.
COS SAID THAT, INDEED, THIS IS A TOPIC OF HIGH CONCERN TO PVALUE
AND ONE THAT WOULD BE WORTH FURTHER EXPLORATION TO DETERMINE
EXACTLY WHERE AND HOW WE MIGHT BE ABLE TO COLLABORATE. AS HQS
IS AWARE, WE HAVE BEEN RELUCTANT TO WORK WITH THE [] ON
NARCOTICS BECAUSE OF COLLAR ALLEGATIONS CONCERNING POSSIBLE
INVOLVEMENT OF [] IN NARCOTICS
TRAFFICKING. WITH [] RECENT DEPARTURE FROM [] THERE,
IN FACT, MAY BE AN OPPORTUNITY IN THIS AREA WHICH THE COS-DESIGNATE
COULD FOLLOW UP WITH THE [].

4. [] ALSO EXPRESSED CONSIDERABLE CONCERN ABOUT PRESIDENT
ALFONSIN'S PHYSICAL PROTECTION, NOTING THAT SHOULD ANYTHING HAPPEN
TO ALFONSIN, THERE IS NO ONE CAPABLE OF STEPPING IN AS HEAD OF
STATE. COS REMINDED [] THAT ON SEVERAL OCCASIONS DURING THE
PAST YEAR COS HAD SUGGESTED TO THE [] THAT THEY CONSIDER
PARTICIPATING IN PVALUE TRAINING RELATED TO INTERNATIONAL
TERRORISM AND VIP PROTECTION. COS ADDED THAT SOME OF THE LOCAL
POLITICAL CONSIDERATIONS AND INTERNAL [] PROBLEMS HAD LESSEN

SUBSTANTIALLY AND SUGGESTED THAT THEY AGAIN REVIEW THE BIDDING CONCERNING THIS TRAINING. [] SEEMED GENUINELY INTERESTED IN PURSUING THIS FURTHER AND SAID HE WOULD GET BACK TO THE STATION ON THIS SUBJECT.
