1. U.S. MARSHALL MR. JOHN PASCUCCI ARRIVED IN BRASILIA AFTERNOON 7 JUNE. HE WAS MET AT AIRPORT BY STATION'S ADMIN ASSISTANT AND BROUGHT TO STATION WHERE HE BRIEFED COS ON HIS MISSION. COS INTRODUCED MR. PASCUCCI TO THE AMBASSADOR AND DCM, AND DURING HALF-HOUR MEETING HE ADVISED AMBASSADOR OF ROLE OF U.S. MARSHALLS SERVICE IN THE INVESTIGATION OF THE REMAINS FOUND IN SAO PAULO. THE AMBASSADOR POSED NO OBJECTIONS, BUT MADE CLEAR HIS DESIRE THAT U.S. MARSHALLS IN BRAZIL TREAD LIGHTLY IN THEIR CONTACTS WITH BRAZILIAN AUTHORITIES, AND TO BE AS COOPERATIVE AS POSSIBLE.

2. COS THEN TOOK MR. PASCUCCI TO TZEB (LIAISON) HQS WHERE MEETING HAD BEEN SCHEDULED WITH TZEBB/74 (E/74). MR PASCUCCI BRIEFED E/74 (THROUGH COS WHO INTERPRETED) ON REASONS FOR HIS PRESENCE IN BRAZIL, AND ASKED FOR TZEBB HELP IN SETTING UP CONTACT WITH PERTINENT BRAZILIAN AUTHORITIES IN SAO PAULO. E/UR SAID HE WOULD HELP, BUT TOLD MR. PASCUCCI THAT TZEBB SERVICE IS NOT INVOLVED IN THE MENGELE INVESTIGATION, THIS TASK FALLING WITHIN THE RESPONSIBILITY OF THE FEDERAL POLICE DEPARTMENT (DPF). FOLLOWING THESE COMMENTS E/UR MADE CALLS TO THE HQS OF THE DPF IN BRASILIA AND SPOKE TO THE DC/DPF. AFTER SEVERAL EXCHANGES, INCLUDING A DELAY TO ALLOW THE DC/DPF TO CALL SAO PAULO, THE DC/DPF PROVIDED A CONTACT NAME, ADDRESS AND PHONE NUMBERS FOR MR. PASCUCCI'S USE IN SAO PAULO. THE NAME PROVIDED WAS THAT OF COL. OSHIRO (LNU), A FORMER TZEBB OFFICER, CURRENTLY SERVING AS REGIONAL POLICE COORDINATOR FOR THE DPF IN SAO PAULO. IN ADDITION TO CONTACT INSTRUCTIONS FOR A MEETING WITH COL. OSHIRO ON THE MORNING OF 10 JUNE, MR. PASCUCCI WAS ALSO GIVEN INSTRUCTIONS FOR EMERGENCY CONTACT OVER THE WEEKEND IF SUCH DEEMED NECESSARY. E/74 ALSO ADVISED MR. PASCUCCI THAT IN EVENT OF NEED FOR FURTHER CONTACT WITH TZEBB SERVICE HE WAS TO COMMUNICATE THIS TO THE [ ] SAO PAULO, WHO WOULD CALL HIS LIAISON CONTACT IN SAO PAULO.

3. FOLLOWING MEETING WITH E/74, MR. PASCUCCI AND COS RETURNED TO THE STATION WHERE HE REPORTED BY PHONE TO HIS SUPERIOR IN WASHINGTON. FROM STATION COS DROVE MR. PASCUCCI TO THE LOCAL AIRPORT WHERE HE EMBARKED ON FLIGHT TO SAO PAULO. ARRANGEMENTS WERE MADE TO HAVE HIM PICKED UP THERE BY [ ] SAO PAULO.

4. U.S. MARSHALLS' LENGTH OF STAY IN BRAZIL WILL BE DEPENDENT ON VISA WHICH HAS BEEN REQUESTED BY THE EMBASSY. BOTH MR. PASCUCCI AND HIS ASSOCIATE, MR. RAFAEL FONSECA, ARRIVED IN BRAZIL WITHOUT VISAS AND WERE ONLY GIVEN A THREE DAY VISA BY AUTHORITIES AT THE RIO
