THE USMS MEDICAL TEAM ADVISED ON 19 JUNE THAT THEIR PRELIMINARY
REPORT SHOULD BE COMPLETED AND TURNED OVER TO DR. TUMA NOON LOCAL
TIME, 20 JUNE, AND A PRESS CONFERENCE IS SCHEDULED FOR 9:00 A.M.
LOCAL TIME, 21 JUNE.

I HAVE NO INFORMATION AS TO THE PROCEDURAL RULES FOR THE
USMS MEDICAL TEAM'S PARTICIPATION, ALTHOUGH FROM PAST EXPERIENCE,
I BELIEVE DR. TUMA WILL HOST THE CONFERENCE WITH MEMBERS OF EACH
TEAM AVAILABLE TO ANSWER QUESTIONS. THEN QUESTIONS WILL BE POSED
TO EACH TEAM AT THEIR RESPECTIVE HOTELS.

IT SHOULD BE NOTED THAT THE POSSIBILITY EXISTS THAT DR. TUMA
MAY CHOOSE TO HOLD A PRESS CONFERENCE 20 JUNE WITH LOCAL AND/OR
INTERNATIONAL MEDIA WITHOUT ADVISING THIS WRITER IN ADVANCE OF
THE MEDICAL TEAM'S PARTICIPATION.

THE USMS MEDICAL TEAM ADVISED THAT THE REPORT WILL BE
STRUCTURED THUSLY: ALL TEAMS WILL ADAPT THE SCIENTIFIC AND
STATISTICAL INFORMATION THAT HAS BEEN GLEANED FROM THE ANTEMORTEM
INVESTIGATION OR COLLECTED FROM THE POSTMORTEM INVESTIGATION OF
THE REMAINS, AND THAT EACH TEAM WILL BE FREE TO DRAW WHATEVER
CONCLUSIONS IT WISHES FROM THOSE FACTS.

I AM ADVISED THAT ALL TEAMS WILL CONCLUDE THAT THE BODY
EXHUMED IN SAO PAULO IS THAT OF JOSEPH MENGELE, THOUGH THE DEGREE
OF CERTAINTY THAT THEY EXPRESS IN THEIR WRITTEN OPINIONS MAY VARY.

I AM FURTHER ADVISED THAT THE JOINT CONCLUSIONS OF ALL THE
TEAMS WILL MORE THAN MEET THE BURDEN OF PROOF IMPOSED BY THE
FEDERAL AND STATE COURTS IN THE U.S.
