SUBJECT: U.S. MARSHAL'S REPORT ON STATUS OF MENGELE
INVESTIGATION

1. U.S. MARSHAL JOHN PASCUCCI HAS REQUESTED THAT THE
FOLLOWING REPORT BE FORWARDED TO MR. DON FERARRONE, CHIEF,
INTERNATIONAL BRANCH U.S. MARSHAL'S SERVICE HEADQUARTERS.
REQUEST [] MAKE THE REPORT AVAILABLE TO THE
AMBASSADOR.

INFORMATION RECEIVED FROM THE USMS MEDICAL TEAM ON 18 JUNE
IS THAT IT APPEARS THE REMAINS ARE THOSE OF JOSEPH MENGELE. ALL
MEMBERS OF THE TEAM HAVE REACHED THAT CONCLUSION INDEPENDENTLY.
DR. SNOW, THE WIESENTHAL TEAM ANTHROPOLOGIST, IS REPORTED TO HAVE
REACHED THE SAME CONCLUSION.

THE MAIN FOCUS OF THE MEDICAL INVESTIGATION IS TO FIND AS
MANY POINTS OF IDENTIFICATION AS POSSIBLE. HOPEFULLY, 25 TO 40.
THIS I AM ADVISED WILL MAKE THE FINDINGS BEYOND DISPUTE. THE
POSSIBILITY OF TWO PERSONS HAVING AS MANY POINTS OF SIMILARITY IS
ASTRONOMICAL.

THE DOCTORS ADVISED THAT THE EXHUMATION OF THE BODY IN
AUSTRIA WOULD ADD TO THE WEIGHT OF THEIR FINDINGS. THEY RECOMMEND
THAT THEY BE PRESENT IN AUSTRIA BEFORE THE GROUND IS BROKEN. IF
THIS IS NOT POSSIBLE, THEY WOULD LIKE TO SUBMIT A THESIS TO THE
AUSTRIANS.

FRIDAY, 21 JUNE, AND REPORT TO DR. TUMA THE EVENING OF 21 JUNE
OR 22 JUNE. THE MEDICAL TEAM IS TO DEPART SAO PAULO THE EVENING
OF 22 JUNE; USMS PERSONNEL TO DEPART 22 JUNE OR 23 JUNE. THESE
TIMES DEPEND UPON THE AVAILABILITY OF POLICE TO LOCATE AND BRING
IN SUBJECTS THAT THE USMS MEDICAL TEAM WISHES TO DEPOSE.

UPON THEIR ARRIVAL IN THE U.S., THE USMS MEDICAL TEAM WISHES
TO HOLD A PRESS CONFERENCE. THEY REQUEST THAT THE DIRECTOR, USMS,
PARTICIPATE. ALSO, REQUESTS HAVE BEEN MADE FOR USMS MEDICAL TEAM
TO APPEAR ON "GOOD MORNING AMERICA" AND POSSIBLY "TODAY". THE
DOCTORS HAVE ADVISED ME THAT THEY WISH THE DIRECTOR TO PARTICIPATE.

THE DOCTORS HAVE BEEN INSTRUCTED BY THIS WRITER AND ARE IN
FULL AGREEMENT THAT AT NO TIME, EITHER WHILE IN BRAZIL OR UPON
RETURN TO THE U.S., WOULD THEY CRITICIZE THE BRAZILIAN POLICE OR

THERE SEEMS TO BE SOME INDICATION THAT THE WEST GERMANS AND THE WIESENTHAL TEAMS MAY LEVEL SEVERE CRITICISM AGAINST THE BRAZILIANS. ALSO, THE WIESENTHAL TEAM MAY ATTACK THE BRAZILIAN AND U.S. EFFORTS, QUESTIONING THE MOTIVATION AND PROFLIGACY OF THE U.S. GOVERNMENT EFFORT.

- 3) MATTERS OF THE PERSONAL NEEDS OR REQUEST OF THE MEDICAL TEAM
- 4) INVESTIGATIVE MATTERS.

BUT INFORMATION BVN ODM DURING THESE MEETINGS THAT IS RELEVANT TO MR. WOLF WILL BE MADE AVAILABLE TO HIM BY THIS WRITER. ALSO, HE WILL BE FULLY INFORMED AS TO THE SOURCE OF THE MEDICAL WORK AND RESULTS OF THAT WORK. THE DOCTORS ARE AVAILABLE TO HIM AT ALL TIMES TO ANSWER ANY QUESTION IN THESE AREAS.
