SOURCE: (S/NF/WN/OR) OTS-Q-0048-85 IS AN ITALIAN BUSINESSMAN WITH WIDE PROFESSIONAL AND SOCIAL CONTACTS WITHIN WESTERN EUROPE.

SUMMARY: (S/NF/WN/OR) GENERAL ADOLPHO ((STROESSNER)), PRESIDENT OF PARAGUAY, RECENTLY ATTENDED A PARTY IN ATHENS, GR GIVEN BY THE HONORARY CONSUL FOR PARAGUAY. AT THE PARTY HE EXPRESSED HIS FEARS FOR THE SAFETY OF HIS TWO DAUGHTERS, ESTRELLA AND TERESITA, WHILE TALKING TO THE HONORARY CONSUL'S WIFE. ACCORDING TO STROESSNER, THE EXILED LEADER OF THE PA LEFTIST OPPOSITION PARTY (NFI) IS PLOTTING TO ABDUCT THE DAUGHTERS WHO ARE ACKNOWLEDGED CHILDREN OF STROESSNER FROM AN EXTRA MARITAL LIAISON IN PA. THE ABDUCTION IS TO OCCUR IN EUROPE DURING A VISIT TO EUROPE THIS SUMMER (NFI). THE EXILED OPPOSITION LEADER, WHO LIVES IN SWITZERLAND, IS BEING HELPED BY ISRAELI AGENTS (NFI). THE DAUGHTERS' ABDUCTION IS DESIGNED TO PRESSURE STROESSNER TO EXTRADITE DR. JOSEF ((MENGELE)) FROM PA. LUIS MARIA ((ARGANA)), A LAWYER HANDLING MENGELE'S AFFAIRS IN PA

(NFI), PROVIDED STROESSNER WITH PART OF THE INFORMATION ON THE ABDUCTION PLOT.

TEXT: (U) SEE SUMMARY.

COMMENTS: 1. (S/NF/WN/OR) SOURCE ATTENDED THE PARTY IN GREECE GIVEN BY THE HONORARY CONSUL (NFI) FOR STROESSNER. THE ABDUCTION INFORMATION WAS OBTAINED IN ITALY BY A TRAINED US INTELLIGENCE OFFICER. SOURCE WAS UNAWARE THE INFORMATION WOULD BE REPORTED IN USI CHANNELS. IT IS NOT KNOWN WHETHER SOURCE OVERHEARD STROESSNER'S CONVERSATION WITH THE HONORARY CONSUL'S WIFE OR OBTAINED THE INFORMATION LATER. ACCORDING TO SOURCE, DR. MENGELE IS PRESENTLY IN PA, CLOSE TO THE BOLIVIAN BORDER AREA, ALTHOUGH THIS MAY BE SOURCE'S ASSUMPTION.

2. (S/NF/WN) AN EVALUATION IS REQUESTED TO DETERMINE WHETHER STROESSNER HAS TRAVELLED TO GREECE RECENTLY AND TO DETERMINE WHETHER FOLLOWUP COLLECTION IS DESIRED. REPORTER HAS NO REASON TO DOUBT SOURCE, BUT HAS NO AVAILABLE INFORMATION TO CONFIRM STROESSNER'S RECENT ACTIVITIES OR TO ASSESS THE OTHER DATA REPORTED.
