"A VAST, DESPICABLE TRADE OF FETUS KIDNEYS IS FLOURISHING IN ASIA. THE COUNTRY OF ORIGIN IS AGAIN SOUTH KOREA. THE COUNTRY OF DESTINATION, IS ONCE AGAIN THE U.S. WITHIN ONLY FIVE YEARS, 12,000 SETS OF FETUS KIDNEYS WERE IMPORTED INTO THE U.S. BY 'FLOW INC.' THIS IS A SUBSIDIARY OF 'GENERAL RESEARCH CORPORATION', A CONGLOMERATE WHICH CARRIES OUT CONTRACTS ON STRATEGIC RESEARCH FOR THE DEPARTMENT OF DEFENSE...." ACCORDING TO THE WRITER, THE FETUSES ARE TAKEN BY CEASARIAN SECTION DURING THE LAST THREE MONTHS OF PREGNANCY, THEY ARE ALIVE AND OPERATED ON TO REMOVE THE KIDNEYS WITHOUT ANAESTHESIA, IN ORDER TO AVOID "RISKS."
