1. UTILITY PROVIDED [USG] FOLLOWING ON 4 OCTOBER. [^{Greek} Official-2]
VISITED UTILITY MORNING 4 OCTOBER, JISCUSSED CASE FULLY, ACCEPTED
PROPOSAL THAT [^{Greek} Official-2] EXPLOIT UPHILL INFORMATION ON MERTEN
IN GREEK PRESS. ON 7 OCTOBER UTILITY WILL HAVE MERTEN DOSSIER
READY WHICH (PRTN GBLD BEING SVCD) SHOW HE IS PROPAGANDA TOOL OF SOVIETS.
MATERIAL COULD NOT BE SURFACED IN GERMANY BECAUSE IS LIBELOUS
AND NOT WATER TIGHT BUT COULD BE REPLAYED IN GERMANY FROM ATHEN
PRESS. UTILITY WILL GIVE US DOSSIER AT SAME TIME FOR POSSIBLE
REPLAY ELSEWHERE BUT ASKS US NOT TO DISCUSS WITH [^{Greek} Official-2] HIS
REVELATION THIS COLLABORATION.

2. INDICATIONS MERTEN IS SERVING SOVIET ENDS REST ON TWO
EARLIER CASES.

A. COL. BOGISLAV VON BONIN CASE OF 1955. MERTEN AND TWO
OTHER LAWYERS, DR. GUSTAV HEINEMANN (SPD MEMBER BUNDESTAG) AND HIS
PARTNER DR. DIETHER POSSER WHERE INVOLVED IN PERSEUDING BONIN TO
JOIN EDITORIAL STAFF COMMUNIST FRONT NEWSPAPER RHEINICSH WESTFAELISCHE
NACHRICHTEN. BONIN WITHDREW WHEN UTILITY PERSONALLY CONVICTED

HIM HE HAD BEEN DUPED. (FRAN COMMENT: [USG] PROBABLY REMEMBERS CASE FROM HIS TIME IN BONN. RATHER EXTENSIVE FRAN FILES DO NOT SHOW INVOLVEMENT MERTEN, HEINEMANN OR POSSER AND UTILITY DID NOT MENTION THEM IN EXTENSIVE CONVERSATIONS WHICH HE THEN HAD WITH [USG] RE THIS CASE.)

B. SAME TRIO INVOLVED IN EFFORT TO PREVENT DR. ROBERT SERVATIUS OF COLOGNE (CLOSE ASSOCIATE BUT NOT MEMBER OF UPHILL) FROM SERVING AS DEFENSE CONSEL FOR EICHMANN. MANEUVERS BY WHICH THEY TRIED GET THIS APPOINTMENT FOR MERTEN HIMSELF CONVINCED UTILITY OF SOVIET BACKING.

3. DIR: NOTE HEINEMANN IS CLOSE FRIEND AND LAWYER CAZAR. [1 USG] WILL ATTEMPT ASK CAZAR SOME DISCREET QUESTIONS 7 OCTOBER.

4. SINCE ALL UPHILL INFO WILL BE GIVEN [^{Greek} Official-2] ANY FURTHER ACTION GERMAN STATION FOR USE IN GREECE WILL HAVE TO COME FROM INDEPENDENT EFFORTS BONN AND HAMBURG INCLUDING [USG] INTERVIEW WITH CAUSA WHICH REQUESTED BUT NOT YET FIRM.
