NO PROOF SUPPLIED; (B) QZ-227 REFERS MEYER VIEWS RE ARTICLE BY GUL IN (1) LEADER AUGUST 1950. NO DEROGATORY INFO; (C) WFP-5092 PARIS INFORMANT (EVALUATION C-3) PRESUMES MEYER "AGENT OF SOVIET SERVICE." REPORTS SOJOURN IN PARIS FEB 1950 WHERE "SAID TO HAVE HAD CONTACTS IN PRO-SOVIET MILIEUX OF RUSSIAN EMIGRATION"; (D) WFPW-1045 JUNE 1950 STATES BARANDWSKI DROPPED MEYER FROM HIS STAFF WHERE HE WAS "LIAISON AND COURIER TO ABROAD"; NO DEROGATORY INFO; (E) WFPW-5177 SPEAKS OF MEYER'S ACTIVITIES GERMANY AND PARIS. STATES "MOST IMPROBABLE THAT SUBJECT MAY BE DOUBLED OR DOUBLING"; (F) WFPW-4234 GIVES MEYER BIOGRAPHY. NO COMMUNIST AFFILIATION REPORTED.

2. ALTHOUGH MENTIONED AS POSSIBLE SOVIET AGENT IN REF WE BELIEVE, FROM INFO HERE, SUBJECT NOT AGENT. POLITICALLY ACTIVE EMIGRES OFTEN DENOUNCED AS SUCH BY OPPOSITION.
