MEMORANDUM FOR RECORD

SUBJECT: Contact with Constantine MIERLAK on Wednesday, 19 June 1957

1. Telephone contact was made with Subject by the undersigned in New York and arrangements made to meet with him in the lobby of his office building at 2 p.m. that afternoon. Contact was made on time and the meeting was conducted in the building cafeteria on the lower level.

2. Subject was told he could contact ZUKOWSKI to notify him that he would be approached by a government representative regarding the AERPADY training. He said he would notify him before the end of the week.

3. The undersigned told Subject there was one more addressee and addressor to clear before parcels could be mailed to them under the package program; i.e., MARTYNOWICZ, Olga and DEMIDENKO, Hoppina. He was told that the other 2 addressees and addressors submitted by him were cleared for use. Subject stated that he would need money for the parcels before he could start because he did not have sufficient funds of his own to even begin. When he comes to Washington in July for the week of assessment the program will be discussed further and the money made available to him at that time.

4. The undersigned told Subject that a hotel reservation was made for him at the Roger Smith Hotel for late arrival on the afternoon of Sunday, 7 July. He is coming to Washington on 7 July via American Airlines Flight No. 569, leaving New York 4:55 p.m. and arriving in Washington at 6:15 p.m. He will check into the hotel by himself and it will not be necessary to meet him at the airport. The undersigned said she would telephone him at the hotel between 8:30 and 8:45 on Monday, 8 July, and then meet with him to introduce the man with whom he would be working that week (A&R staff). Subject stated he had many things to do while he was in Washington, people to see in Congress, etc. and hoped that he would have some free afternoons in which to accomplish this. The undersigned told him not to count on free afternoons because his time his time would be fully occupied but that he could try to arrange something with the men with whom he would be working after he arrived here.

5. Subject was reimbursed \$12.52 for travel expenses incurred on 11-12 May 1957 during a trip to New Brunswick and South River, New Jersey, accounting for which he submitted on 14 May 1957. Subject signed a receipt for the \$12.52 and it was turned over to DOB/Finance Officer on 20 June 1957.

6. The meeting was terminated at approximately 2:30 p.m. The next contact was scheduled for Monday, 8 July, at the Roger Smith Hotel in Washington.

SECRECY AGREEMENT

1. I,, understand that I may be the recipient of information which concerns the present and future security of the United States and which belongs to the United States. This information together with the methods of collecting and handling it, are classified according to security standards set by the U.S. Government.

2. I acknowledge that I do not now, nor shall I ever possess any right, interest, title or claim in or to any of the information or intelligence or methods of collecting or handling it which has come or shall come to my attention by virtue of my connection with the U.S. Government, but shall always recognize the property right of the United States of America, in and to such matters.

3. I do solemnly swear that I will never divulge, publish, or reveal either by word, conduct, or any other means any classified intelligence or knowledge, except in the performance of my official duties and in accordance with the laws of the United States, unless specifically authorized in writing, in each case, by the U.S. Government.

4. I understand that no change in my relationship with the U.S. Government will relieve me of my obligation under this oath and that the provisions of this oath will remain binding upon me even after the termination of my services with the U.S. Government.

5. I take this obligation freely, without any mental reservation or purpose of evasion.
