MEMORANDUM FOR RECORD

SUBJECT: Contact with AEPIMER-1 on 22 July 1957

1. Telephone contact with Subject was made by the undersigned in New York at 1130 hours on Monday, 22 July, and arrangements were made to meet with him for luncheon. Subject was waiting in the lobby of his office building when the undersigned arrived at 1205 hours. The meeting was conducted during luncheon in the building restaurant.

2. Subject stated he had an airlines ticket stub for [] and for the undersigned, a translation of the letter received from Argentina but that he had left them at home. He was given an Arlington Post Office address for communication purposes and was requested to mail the ticket stub and the letter to this address. Subject again told the undersigned that the letter received from Poland was very important and he requested that it be brought to the attention of the appropriate individuals. The undersigned promised this would be done.

3. The undersigned gave Subject \$300.00 (receipt signed by Subject and filed in the AEPULFILL file) for use in connection with the Byelorussian package program. Subject told the undersigned he would like to add his father's name to the list of addressees under the package program. He has mailed packages to his father in the past and is in correspondence with him. Subject stated that in the event of his father's death, the parcels could continue to go to the same address to the attention of his brother who lives with his family. Subject does not use his true name for the return address on the parcels and correspondence to his father. He has been using the following return address:

father as an addressee, Subject will be notified by the undersigned. He promised to wait for instructions before undertaking any action in this regard.

4. Subject promised to make a translation of the original letter received from Byelorussia by the Byelorussian organization in Argentina for Mr. A. Adamovich, if a copy of the original is supplied to him. The original is in the hands of Mr. Adamovich who has gone for a month's visit in Europe. The undersigned promised to give Subject a copy of the letter at the next meeting.

5. The meeting was terminated at 1310 hours. No time or place was specified for the next meeting.
