Review of file: Jakob LOELLGEN [redacted] born 17 March, 1897

In relation to the Gestapo MUELLER Case.

4-6 March, 1951 GOLEINIEWSKI said: At the time he was stationed in Danzig ~~15x~~ (1950-52) and was in close touch with a series of RIS officers he learned: LOELLGEN had been turned by the RIS during the war (1943) and had worked for them at least two years while he was still Chief of the Gestapo in Danzig. Later, he returned to Germany. The Russians picked up Heinrich (Gestapo) MUELLER who was the Chief of Amt IV of the RSHA (Gestapo) and took him to Russia. Possibly as a result of their apprehension of MUELLER, according to source and with his help the Russians allegedly recruited Otto SKORZENY before the end of the war while he was head of the Mil. Amt ~~undemx~~ of RSHA under SCHELLENBERG. (YT 664 in [redacted] file). Also, KASZUBOWSKI was recruited by RIS in 1947, on basis LOELLGEN lead

By July 1961 this information had been conveyed in one way or another to the BND and the BND located "LOELLGEN" as residing in Trier. He was chief of the Trier police until 1957 when pensioned. (Note: same cable (MUNI 6411) mentions another alleged MUELLER contact: Johannes KASSNER, born KASZUBOWSKI 5 October 1902, who returned Fed Rep 1959 BfV Warning list). It soon turned out LOELLGEN had been special connection of BND.

Search of the German Primer confirmed LOELLGEN existence and Danzig job in World War II.

MUNI 6499 10 July discloses BND also after one Alarich BROSS, born 25 March, 1904 a special contact of theirs who was also contact of LOELLGEN and KASSNER.

WAST traces confirmed LOELLGEN RSHA man with right to wear SS Major uniform. NSDAP member 3 575 800

MUNI 6564 traced Hans Joachim LEYER, born 2 Novem 1908 Danzig, deputy to LOELLGEN in ~~xxxx~~ Danzig. Oct 1958 BfV report said BND had recruited LEYER and SKRYPIETZ alias KASSNER, but this not true, LEYER was BfV source. "EGQA 56756" no longer avail HQ stated LEYER attended private meetings of NAUMANN Circle ~~xxxx~~ Hamburg etc.

By mid July 1961 BND was promoting an operation to end in the arrest of LOELLGEN, KASSNER and LEYER. (Of course FELFE investigation was also then in full swing...)

Muni 6639 24 July 1961: One Dr. Hans SCHMITZ born 30 Jan 1903 set up detective agency in Koeln, believed to be IW detective agency LOELLGEN and KASSNER formerly connected with.

Later (EGMA 57888 BND decided it had too much to do already to go after LOELLGEN.

Later on the HACKE affair, GOLEINIEWSKI said: The Major ROGULSKI had run KASZUBOWSKI in the West. K. had built up such a reputation that he was being considered to run the ~~xxxx~~ new BfV. ABAKUMOW had his own candidate, NU, and accordingly saw to it that KASSUBOWSKI was arrested in the East during a meeting with ROGULSKI and kept out of circulation until about 1957. But ABAKUMOW's prospect went awry and did not get the job. KASZUBOWSKI hated the Russians but agreed to work for the Poles in the West. ROGULSKI got mad also and went into diplomatic service (Not much later ABAKUMOW was jailed and killed).

~~Goleinowski~~ pictured the neo-Nazi org which he called HACKE to be a trust manipulated by the RIS through witting Nazis who have become RIS agents (SKORZENY, RUDL, ROGAL, etc.) Nazi search and rescue org like HIAG are said to be used by the RIS.

A later murdered defector [redacted] confirmed the ROGULSKI/KASZUBOWSKI
