1. NEY is no member of this Organisation.

The following is known about him (see 34.3/No 331 of 9 Feb 49, para 2(b); 26 Nov 48, para 2(x) and (b); 6 Dec 48, para 1 - 3):-

Dr. Karoly NEY - There is a report about him on hand, dated from the beginning of July 1948. According to this report, French ~~emigration~~ circles have tried to contact the Hungarian National Emigration. The French had suggested to form semi-military police units out of young Hungarian emigrants in the French zones of Germany and Austria. According to this report, NEY pointed out that the Hungarian side would prefer to get in closer contact with the Americans. He is not very keen on the French proposition as he is afraid that the French suggestion would ultimately lead to nothing more than a sort of "Foreign Legion". NEY himself is being described as an impressive and intelligent person, full of vitality. He plays an important role within the Hungarian emigration and is considered as the military exponent of a future Hungary. He is a convinced Anti-Bolshevist and has considerable connections abroad. The report states further that in 1946 he was sentenced to death by an American Military Court at SALZBURG for the execution of air-men carried out by his unit during the war. He was pardoned though and later-on released from jail.

The a/m report was submitted to 23 under No J-181 on 20 Aug 48.

Dr. Karoly NEY is, according to information received, not in contact with the official Hungarian Liberty Movement of General FARCAK.

He is said to be living no longer in SALZBURG but in the surroundings of LINZ.

Closely connected with him is a Dr. Caroly JAKO, IMMERBUCH.

At present NEY is co-operating with the CIC official, MORNINGSTAR GMUNDEN. The hunters' hut near GMUNDEN is being used by him for training of ~~his own men~~. Up to present 14 men have been trained, 10 of them ~~are~~ however, said to have left. One of these persons, SZEKELY, MAYOR, was arrested with his co-workers in Hungary.
