1. XNMALEDICT leaders called on [] yesterday to discuss, among other things, the Pine Tree team.
2. Leaders state [] and [] are in correspondence with Happold, and write the following:
 - A. Identities (1) and (2) are working only in behalf of Kaempfer and use every means to discredit HTNEIGH.
 - B. [] and [] fear for their lives and believe Identities (1) and (2) plan to kill them when the opportune moment arrives.
 - C. [] and [] ask Happold to use a mail cut-out, through which they are corresponding, to send them support so they can break away from Identities (1) and (2) and establish an independent operation.
3. There may be a shread of truth in the foregoing but Gallogly doubts it.
4. XNMALEDICT leaders know that the Red team, comprised of Ockleshaw elements, is again active. Also, they distrust Kaempfer elements. They are thus anxious to have an XNMALEDICT team of their own to spread the XNMALEDICT gospel and possibly to discredit Ockleshaw and Kaempfer -- possibly to slip the knife into HTNEIGH here and there, too, if the opportunity presents itself.
5. [] suggests HTGRUBBY might broadcast to Pine Tree that they should not write their exiled leaders except through authorized channels (for their own safety), but in order to let their leaders know they are happy and get on well as a group they should send out a letter signed by all expressing their desire to continue as a team.
6. This letter can be passed along to Happold to refute his case.
