1. There are forwarded herewith Source's Italian translations of two letters dated 21 and 22 August 1952, written by [ ] from Sabac.
2. Writer informs Source that on 10 August he and [ ] began working (as mechanic and electrician, respectively) at the "Zorka" chemical factory at Sabac in order to add to the 3000 Dinar monthly subsidy which they receive from the Yugoslav Government, a sum insufficient to provide for their complete maintenance. Also, as explained to them by Colonel Cedo MIJOVIC, everyone must work in order to make a success of the Socialist program.
3. In his 21 August letter [ ] reports the outcome of a Yugoslav sponsored six-man mission into Albania. Ded PJETRA (who killed a Communist sergeant and major at Ura e Mesit), Gjon DEDA, and an unidentified Mirdite are reported to be still alive but have not yet returned to Jugoslavia. Hil SLLAKU, Shpend DUSHANI (a former Albanian Government security agent who defected to Jugoslavia in February 1951) and a third unidentified individual were killed.
4. A few days prior to the date of his letter, [ ] reports, a mission including [ ] and Pjeter SMAJLI entered Albania.
5. In his second letter, chiefly by way of confirming previous informations, but, unfortunately, without specifying dates or describing circumstances, writer gives the following information concerning the individuals mentioned:
  - a) Arrive Skoplje: The brothers Ndue, Pal, and Martin LALA, one son of Gjergj Nicol NDREU plus three unidentified individuals from Kruja.

b) Killed :

Gjergj N. NDREU and his son Zef, Jak LALA, Gjon N. NDREU's sons Kol and Mark, Llesh Gjok LALA's son Pjeter, and Geg Zef HYSENI.

c) Wounded: and captured by enemy:

Gjon Lale FIROLI, Pjeter Marka NDOJ, Gjon Ndue PERJAKU, plus a fourth unidentified individual who later died.

d) The entire group above was betrayed at Mamurash by one Gjin GARA from Perlati.

6. The letter goes on to report the following items:

a) On 11 August Pjeter KIMZA, Dom Zef COKU (Dom Zef OROSHI) Frrok N. JAKU, Kol PERDODA, Ndue Jak ZEFI plus five other unidentified individuals arrived Jugoslavia.

b) Members of another ten-man group previously guided into Jugoslavia by Pjeter Cup Qafa reported the deaths in Albania of 15 individuals including:

Llesh KAZJU  
Frrok Z. PESHKU  
Prend Ndue MARKU  
Ndue Llesh FRROKU  
Preng Zef MARKU  
Zef and Dod COKU  
Marka Pjeter GJINI

Llesh FRROKU  
Dod Frrok NDOJ  
Zef Marka TUCI

c) Practically all resistance leaders have been arrested in Albania, and Llesh Frrok GECI, Preng Gjok DEKA and his sons, and Osman VERA have surrendered to Government forces.

d) Ded PJETRA, according to an unconfirmed report, has been killed (see also para. 3 above).

7. Writer concludes by expressing his opinion that the Yugoslavs have deliberately destroyed the organization of former CHARITY support in Albania.
