Following is the regular BGFIND [ ] report for the period  
15 August to 16 September 1952:

1. General HTNEIGH Activities:

During the period covered by this report a continuous series of meetings has been held between the ZRCROWN and PBPRIME representatives, the ZRCROWN/PBPRIME representatives and the HTNEIGH, and the PBPRIME representative and various individual members of HTNEIGH, concerning the proposed reorganization and broadening of HTNEIGH. Briefly, the situation can be summarized as follows:

a. [ ] [ ] is against the entry of [ ] [ ] and [ ] [ ] into the Central Committee, planned to replace the Executive Committee and the Consultative Committee by the ZRCROWN/PBPRIME backers.

b. [ ] [ ] representing the professor faction of XNMALEDICT, is against the entry of [ ] [ ] and Identity (1).

c. Henry R. Malament and [ ] [ ] are in favor of the ZRCROWN/PBPRIME sponsored plan. Malament, however, is fearful of making any commitments publicly and seeks to sway his cohorts through personal conversations, which appear to run around the clock seven days a week. [ ] [ ], on the other hand, is an open advocate of reorganizing and broadening.

d. [ ] [ ] states privately that he is for the reorganization and broadening of the Committee, but publicly he lobbies against it. His lame excuse is that he is bound by the decision reached by the Central Committee of the HTMELON Movement. Actually, [ ] [ ] has very little to say, even within the HTMELON Movement. He takes orders from [ ] [ ] and does exactly what [ ] [ ] tells him to do.

e. [ ] [ ] and [ ] [ ] have made a deal, which was brought about by the professors convincing [ ] [ ] that his position as the

"Chieftain" in the HTNEIGH would be weakened if [ ] and [ ] were put on a footing equal to his. Thus, [ ] is committee to hold out against [ ] and [ ] interests, and the professors are committed to block the entry of representatives of BGPREFIX and [ ] interests.

f. The ZRCROWNS are greatly disturbed by the fact that elements they thought were under their control have rebelled and refuse to obey the ZRCROWN command that they now accept the reorganization and broadening of HTNEIGH.

g. It can be expected that these negotiations will last weeks, possibly months, unless some unforeseen developments occur. [ ] is not trying to push for an early decision but is endeavoring to keep the situation in a state of elasticity. This is being done purposely in order to find out more about why the ZRCROWNS switched signals (A month ago they were sabotaging the broadening of the Committee; now they desire it as much, if not more, than the PEPRIMS do.) and to try to uncover more information on the aims and policies of the TPROACHES and their EMSTRIDE group.

## 2. HTNEIGH Executive Committee Activities:

Obviously, with all the discussions going on with regard to the reorganization and broadening, little has been accomplished by the Executive Committee. The only matter of importance that has been dealt with during the period covered by this report is the preparation of the brief on slave labor conditions within KWAAHOO for possible presentation to the United Nations Ad Hoc Committee meeting in Geneva in October. As of this writing, final word has not been received from the Ad Hoc Committee Chairman as to whether or not the HTNEIGH will be heard.

## 3. BGFUME Committee Activities:

There is little to report on the activities of the BGFUME Committee other than the fact that it becomes increasingly difficult to get out each issue because of the lack of intelligence material upon which to base articles. A plan is being discussed with Athens headquarters this week under which various members of the BGFUME Committee may be taken into KWAAHOO, one at a time, with the Willow Team, in order that they can gather material firsthand for use in QKPALING and KMBUMPSY.

4. Like the Executive Committee, the Military Junta was rather inactive during the period covered by this report. The great concern of the Junta at the moment is the disposal of the 38 agents in BCBIDDY whom the ZRCROWNS want to resettle in Australia. The Military Junta feels that it is not getting a fair deal from the ZRCROWNS and has flatly refused to travel to BCBIDDY to urge the 38 ex-agents to migrate to Australia. The attitude taken by the Junta is that they recruited the elements in good faith,

the ZRCROWNS used them, and now that the ZRCROWNS have no further need for them they wish to dispose of them, thereby placing HUNNIGH in a bad light among the exiles they are trying to attract to the cause.

The best cooperation RNLUMPIT has been able to extract from the Military Junta is an open letter to the elements in DTETHYL, advising them to request the ZRCROWN government to resettle them in HECURIO or Canada, where they can be on tap for use by the Committee when their services are again required. This, obviously, is an unsatisfactory answer for the ZRCROWNS. RNLUMPIT is applying heat about once a week to try to get the leaders to travel to DTETHYL for a visit, hoping that once they have them in BGBIDDY they can lay down the law and the leaders will issue firm instructions to their rebellious followers.

5. Attached is a report of activities of the Committee during the period August 10 to September 10, prepared by the Secretary of HUNNIGH.

**REPORT ON THE ACTIVITIES OF THE EXECUTIVE COMMITTEE OF THE NCFA  
DURING THE PERIOD 10th AUGUST - 10th SEPTEMBER 1952.**

The Executive Committee of the NCFA held several meetings during this period concerning the following matters:

1. Mr. Zef PALI presented a relation on his private visit to Turkey.
2. Mr. A.L. requested the members of the Military Junta to have their documents ready, by the end of the month of August, for their departure to England where they will visit the Albanians living in Bicester, Oxon.
3. The military Junta discussed the question of the elements who are in England, and requested Mr. J.L. to find a solution for their settlement within reach of the Committee.
4. All the members of the Executive Committee have attended a meeting with Mr. J.L. and Mr. A.L., on the 20th and 23rd August 52, during which they have acknowledged the promemo and suggestions made by the backers of the Committee, as well as their verbal suggestions concerning the broadening and reorganisation of the NCFA.
5. The Executive Committee has been informed of the note forwarded by Mr. J.L. concerning the sum of twelve dollars per day, which will cover in the future all expenses incurred by the members of the NCFA, besides their transportation expenses.
6. The Executive Committee has prepared its decision as answer to the joint memorandum of the backers

of the Committee concerning the broadening and reorganisation of the NCFA. They will soon present it to Mr. J.L. and Mr. A.L.

3. The Committee has also attended a meeting with Mr. Damani, concerning the presentation of a memorandum to the UNO about the forced labour camps in Albania. Mr. Damani has been given the material gathered in Greece by Mr. Toptani. Meanwhile the chairman of the NCFA has sent a cable to the Committee of the Slave Labour Hearings in Geneva, to let them know about the sending of a memorandum by the NCFA.
