REPORT ON THE ACTIVITIES OF THE EXECUTIVE COMMITTEE OF THE NCFA
 DURING THE PERIOD 10th NOVEMBER - 10th DECEMBER 1952.-

The Executive Committee of the NCFA held some meetings during this period, concerning the following matters:

1. The Executive Committee has studied the message prepared by the Friends concerning the discussions which took place in Rome, for the broadening and reorganization of the NCFA. The Executive has made counter proposals to this message and prepared their own. However, this matter was left in suspense and the discussions have been adjourned until next Spring.
2. The Executive Committee has prepared a fifteen minutes interview for Radio Free Europe, on the occasion of the 28 November, under the form of an interview, and at the same time approved the message prepared by the Chairman, Mr. Dosti for the B.B.C.
3. The Committee has nominated a delegation composed by MM. Said Kryeziu and Zef Pali, to present to the Director of Radio Rome, the reasons of the non-participation of the NCFA, in their programme for the 28 November.
4. The Executive Committee has studied the matter concerning the nomination of a commission for the control of the Finances of the NCFA.
5. The Executive Committee has decided to reduce the payment of Mr. Spahija, from 200 dollars monthly to 150 dollars, starting December 1952.
5. The members of the Executive Committee who had been called from New York, have returned to their quarters: Mr. Kotta, left for Paris, enroute to N.Y. on the 22 Mr. Dosti, on the 23 December. Mr. Kupi has left for Egypt on the 24.

7. On the occasion of the 28 November the Executive Committee has sent a delegation composed by MM. Myftar Spahija, Nexhat Peshkepija and Atlant Koçi to the refugee camp of Aversa, where a party was held for the Albanian refugees living there.
8. As the refugees living in the Camp of Fraschette d' Alatri were not authorised to get out of camp, the Executive Committee has decided to send them a sum of 12.000 It.L., on the occasion of the 28 November 1952.-
