1. Reference was given full consideration by various echelons and Divisions concerned. The following paragraphs contain the conclusions reached here.

2. Substantive

a. SHELLAG, OBTEST and METAPHOR broadcasts should be discontinued on the dates indicated by you. It is not intended to maintain a capability for the production of tapes for these broadcasts at other locations. For all intents and purposes these activities will be fully terminated.

b. METAPHOR I can be continued on the assumption that (1) a senior KUCAGE Staff Officer like  will give adequate supervision to DOCHKAB and (2) the facilities which the  can give you will warrant the fulltime utilization of DOCHKAB for this particular purpose (see DIR 47049, 3 October 1959).

c. HICLASSY tapes will be furnished you as heretofore, again on the assumption that the Communications Base facilities available under the terms of DIR 47049 will warrant the continuation of this project.

d. A decision on PYREX broadcasts to the USSR is deferred until the results of the current four-week stoppage of these broadcasts are further analysed (see DIR 48217, 13 October 1959).

3. Administrative

a. Staff employees

(1) Headquarters agrees to your moving  to other duties, especially since  will not return to your station.

(2) We concur in your not replacing  on the completion of his present tour in December 1959.

(3) As you know,  who has spent considerable time on OBTEST will not be replaced on the completion of his present tour.

b. Contract/Field agents

(1) We concur in your moving  into Yugoslav operations.

(2) We believe that AIPLERE should be expeditiously terminated.

(3) We concur that GOALEHT be returned sometime after 31 October 1959 for termination - the actual date to be worked out between you and the Branch concerned.

(4) We will not return MYNTHON to your

(6) It is felt that an effort might be made to restread FANNINGU (see DIR 49603, 22 October 1959).
