1. [] has passed us a detailed brief on all the steps Jagged have taken to implement the agreements they made at the FIEND/Valuable talks in BGBIDDY, 22-23 January 1951. He reports as follows:

a. Item 1, para 3. [] has requested Jagged's representative in TPCREDO to approach [] in order to ascertain whether he would be willing to put his HBPIXIE BGHIVES at FJCAPE/Jagged disposal.

b. Item 2, para 3. [] in TPCREDO has been given a supplementary brief to cover this point.

c. Item 2, para 4. Three thousand leaflets have been prepared and are now awaiting dispatch to LCDRINK, where they should arrive in the course of the next ten days.

d. Item 2(c), para 2. The information requested is being procured and will be supplied as soon as completed.

e. Item 2(c), para 3. A complete set of KMULCER charts have been procured for FJCAPE, and Jagged are now awaiting their arrival in KMTUNIC. When they are received, they will be passed to [] for forwarding to LCDRINK.

f. Item 2(c), para 4. Jagged have procured JBHOMER maps covering the northern part of HBPIXIE. As soon as Jagged have made photographic copies of the maps, they will forward the originals to [] for dispatch to LCDRINK. (Jagged are requesting JBHOMER to forward further copies covering the entire country.)

g. Item 2(c), para 5. The maps requested were forwarded by us under 507-CLEWU, dated 5 February 1951. The Handbooks on HBPIXIE and HTDREAM are forwarded to LCDRINK under separate cover as Attachment to this dispatch.

h. Item 9, para 5. [] 8269 explains Jagged's situation this matter. (6)

i. Item 15, para 4. Jagged have written to BGQUIET to inquire their views regarding the possible transfer of HTNEIGH, but have not yet received their reply. On the other hand, [] has discussed this matter in Jagged Headquarters, and it is felt almost certain the BGQUIETS would view such a proposal with disfavor.

j. Item 15, para 5. Jagged's liaison officer to [] has been instructed to inform the latter of Donn O. Cuckleshaw's visit to KMTUNIC in order to dispel the KMULCER fears that we are exclusively playing with XNMALEDICT. [] in TPCREDO has also been instructed to extend an invitation to Lorton A. Tewell to visit BGBIDDY. (11)

k. Item 17, para 2. Jagged have [] with FJMINOR, and they hope to furnish latest statistics as soon as possible.

2. The question of aerial reconnaissance (Item 2(c), para 3,) is now in hand, and we of the details in a cable dated 9 February (yet received).
