AGREEMENT BETWEEN THE NATIONAL COMMITTEE FOR FREE ALBANIA
AND OFFICIAL EMISSARY

I, _____, the undersigned,
having been appointed an Official Emissary of the National Com-
mittee for Free Albania, contribute my services to that organi-
zation voluntarily.

It is understood, however, that in return for such services as
I may render to the Committee I am to receive certain gratuities.
These gratuities, and the conditions under which they apply, are:

1. For the period that I am in the service of the National
Committee for Free Albania and perform the duties assigned
to me I am to receive a sum of \$50.00 (fifty dollars), or
the equivalent of \$50.00, per month.
2. In the event of my capture by the opposition and subsequent
inability to perform my duties, it is understood that my
gratuity of \$50.00 per month is to be continued for a period
not to exceed two years. In return for this consideration,
I agree not to divulge any secrets of the National Committee
for Free Albania.
3. In the event of my defection to a country or power unfriendly
to (or not cooperating with) the National Committee for Free
Albania, it is understood that my gratuities will cease
immediately upon receipt of evidence by the Committee that
I have entered the service of such country or power. In

any event, it is understood that my gratuity of \$50.00 per month will cease after one year's tenure in such country - unless I establish the fact that I am doing everything in my power to re-enter Albania in the interests of the National Committee for Free Albania or have made my way to a country not unfriendly to the Committee and have made every effort to establish contact with Committee representatives and avail myself to the Committee's orders.

4. The gratuities to be given me by the National Committee for Free Albania are to be dispensed with in the following manner during any period in which I am engaged in activities for the Committee and my inaccessibility makes it impossible for my gratuities to be given to me personally: _____

5. In the event of my capture, any gratuities given me are to be dispensed with in the following manner: _____

6. In the event of my defection to a country unfriendly toward the National Committee for Free Albania, it is understood that any gratuities given me are to be dispensed with in the following manner: _____
