1. It has been our strong feeling that [ ] should return as soon as possible to his post [ ] His return had already been long delayed in view of our intention to keep him here for the proposed FIEND/VALUABLE Washington meeting which was subsequently cancelled by London. Consequently, [ ] has been directed to return to his post and is now enroute directly [ ] by sea. In view of [ ] prolonged absence [ ] we do not feel that we possess sufficient information to come to an intelligent conclusion in the case of Gagi Gogo. It is noted that the BK promeria was delivered to [ ] at a time when [ ] was absent from Rome and that the same document was presented to [ ] after [ ] departure for Washington on orders. Under these circumstances, it appears to us both logical and necessary that [ ] and [ ] reach a joint understanding as to their interpretation of this incident before any possibly premature and ill-informed decisions are reached at the Washington-London level. It was our hope, unfortunately dashed by London, that the proposed Washington meeting would bring [ ] and their responsible superiors together under circumstances which would permit an intelligent discussion of, and mutually satisfactory decision concerning, this incident.

2. We therefore feel it necessary that no action be taken concerning the case of Mr. Gogo until discussions have taken place between [ ] and [ ] It is our earnest hope that these discussions will lead to an amicable resolution of the incident and that no further headquarters concern need be expended, either in Washington or in London.

3. In the event that [ ] and [ ] are unable to reach an agreement in this matter, we suggest that the question then be referred to a higher level FIEND/VALUABLE meeting which we hope can be arranged later in the summer and at which we hope to discuss a number of matters, including those items proposed by London as part of the agenda for the 8 June meeting which was cancelled.

4. If it should unfortunately prove unavoidable to handle the Gogo matter on a showdown basis as demanded by the BK, rather than on a basis of mutual adjustment and conciliation, we feel that it would also become unavoidable that other problems which have been festering in NCFAs be brought before the NCFAs executive committee to be handled on a comparable basis. We strongly feel, however, that this would be equally unfortunate and that all outstanding problems should be handled by conciliation. We further feel that it is absolutely essential to the success of this activity that the British and Americans present a united front to the NCFAs as a whole.

5. We hold no brief for Mr. Gogo personally and do not pre-judge him one way or the other. Nor do we feel prepared at this point to support either his retention or removal from his present position. We do not, however, consider Mr. Ihsan Toptani to be an acceptable replacement.

SUBJECT: BGFIEND/VALUABLE

REFERENCE: Memorandum for the File, Subject as Above, Dated 1 June, 1953.

1. It is requested that you pass the following points to [ ] your early convenience:

A. With regard to the return of [ ] to his post it is our feeling that in view of our urgent need for his services in the field he should return without further delay and without passing through London. We would recall that [ ] return [ ] was postponed once already, at some inconvenience, with a view to holding him here for the proposed FIEND/VALUABLE meeting in Washington, which was subsequently cancelled. Mr. Lieb was able to make reservations on the Andrea Doria, leaving New York at noon on 3 June and we do not wish to delay his return to his post, where the situation among the emigre politicians is such that his presence is urgently required. We remain ready to discuss the Gogo incident on either the Washington-London level or the Rome Liaison level, but we see no need for [ ] to proceed to London before returning to Rome.

B. We propose that, upon his return [ ] take no action with respect to the charges levelled at Mr. Gaqi Gogo until such time as he has reached full agreement with [ ]. If at the time it appears that those charges are sufficiently serious to warrant taking action against Gogo, we propose, partly in the interest of fair play but even more with a view to clearing up what appears to be a very unwholesome situation in the NCFE in particular and the Albanian emigration in general, that certain other matters also be referred to the Executive Committee for decision, matters involving the irregular and unauthorized activities of other members of the NCFE.

C. In the event that [ ] and [ ] are unable to reach agreement on the handling of the Gogo problem, we suggest that the question be referred to a high-level FIEND/VALUABLE meeting which we hope can be arranged later in the summer and at which we hope to discuss a number of important matters.

2. We pass on the following points for the information of [redacted] in his discussions with [redacted] and to help him in answering any questions which might be put to him by the British representatives.

A. The memorandum passed to [redacted] by the BK could not be discussed with [redacted] before [redacted] departure [redacted] (on orders and not on vacation). since [redacted] was away [redacted] not returning until after [redacted] had left the city.

B. At the time of his discussions with the BK representatives, [redacted] was requested to consider them as confidential in nature and to be treated only between the BK and himself; at the conclusion of these meetings [redacted] (as specifically requested by Vasil Andoni to "consider things as they were" prior to the discussions. In view of this it was [redacted] understanding that no action would be taken before his return [redacted]. The passing of the memorandum to [redacted] immediately after [redacted] departure not only constitutes a breach of faith on the part of the BK representatives but raises obvious questions as to their motives.

C. Upon [redacted] arrival in Washington he reported fully to his headquarters. Since this matter appeared to be one which could best be handled on the level of our Rome liaison--especially since any action which might be taken would have to be on the basis of an Executive Committee decision rather than on the strength of a unilateral demand by one of the component elements of the NCFA--we advised [redacted] on 9 May 1953 (OUT 60113) that [redacted] would return direct [redacted] it being understood that, if [redacted] failed to reach agreement, the matter would be reviewed by London and Washington. It was made clear at that time that, while we made no brief for Gagi Gogo, we did not consider Ihsan Toptani to be a desirable replacement.

D. When, on 22 May, we were advised (IN 26937) that London considered this matter sufficiently important to warrant handling by Washington and London, we immediately (23 May) advised [redacted] and [redacted] (OUT 63188) that we would be very happy to meet with MI-6 representatives in Washington at the earliest possible date to discuss this and other matters relating to the NCFA.

E. Upon receipt of London agreement to such a meeting (26 May, IN 27738) we immediately cancelled [redacted] reservations in order to hold him over until the conferences were completed c. 12 June.

F. It was, therefore, with some surprise that (28 May) we learned that the meeting was not to be held after all, (IN 28543) on the grounds that "discussions concerning a single operation by a case officer did not warrant such extended travel"--since we understood (IN 28034 and IN 26937) that both [redacted] and [redacted]

SUBJECT: BGFIEND/VALUABLE

[ ] British Secret Service (MI-6) Representative in Washington, raised the following points on 1 June 1953.

Prior to the time that [ ] left [ ] he received a memorandum from the BK of the Committee for Free Albania. This memorandum stated that GOGA must be fired or the BK would split off from the Committee for Free Albania. The reason given was that the BK has no faith in GOGA's integrity and alleged that GOGA has misapplied funds to run some of his own agents.

[ ] [ ] stated that his Service has been prodding [ ] CIA case officer, for some American reaction to the above situation. No reply has been forthcoming.

[ ] Service considers it essential that there shall be some joint policy on this matter prior to the time that [ ] returns to Rome.

[ ] further stated that:

(a) GOGA belongs to the Legalitat Party. While the BK is prepared to accept another member of the Legalitat, they are not prepared to accept GOGA. The objection is to the man and not to the Party.

(b) The Secret Service (MI-6) does not know the rights and wrongs of the BK complaint but feel in general that GOGA is unsatisfactory and it would be better if he were out of the way.

[ ] suggested that the above be called to the attention of [ ] since the subject might arise during the London

meetings. He emphasized that the important thing is to settle on a joint policy prior to the time that [ ] departs for Rome.
