Following is text of a message received from Aircert which is the subject of reference:

"We have no objection to the joint announcement being made sooner than we tentatively agreed the other day and have instructed RNLUMPIT to concert timing locally with [] Will you please note, however, that all our recent communications with RNLUMPIT on the subject of his withdrawal and the arrangements to be made before then have been sent by bag. We shall be grateful therefore if [] would keep to himself any instructions he receives from Washington and only discuss with PNLUMPIT when the latter broaches the subject, i.e., when he will have received our letters. Owing to the Easter holiday we do not quite know when this will be.

"We do, however, wish to see and approve the joint announcement to be made by RNLUMPIT and [] before it is handed to the Committee, and we have instructed [] to submit a draft as soon as possible. We will of course send our approval or otherwise by signal, but this does mean that the announcement can probably not be made before 1st May.

"I now note that in my reply to your letter of 5 April I made no comment about Samuel H. Pashley. I feel that you should be under no illusion as to our views about this man which, put quite bluntly, are that he is not only a knave but also a fool. We can therefore only advise you that in our view it is quite wrong to entrust him with the publication of QKPALING in New York cr, for that matter, to give him any position where he could cause harm to the Albanian cause."
