AICOCK Monthly Activities Report

Synopsis

AICOCK reports on behavior of Lavrion refugees and submits biographic information on Lavrion inmates.

Account of Developments

1. AICOCK was contacted by [] on the 27th of May and on 10 June during this period.

2. AICOCK passed along the following information to [] at the HTNEIGH headquarters on 27 May - 1500 to 1600. AICOCK believes GACCENT is a British agent because he is continually harping on the theme that the "Americans" do not know how to handle teams, and that after they have used an individual they discard him - in contrast with the British who treat their agents like human beings and take care of them after their immediate usefulness has ended. GACCENT has also been urging Kossovars to return to Yugoslavia; espousing that HTNEIGH has no value because it refuses to ask for the return of Kossova and that the Legalitet Party is cowardly because they do not seek personal revenge on Hagan Ditari and other Agrarians for the knife fight. AICOCK also expressed his opinion that the camp authorities do not take proper measures to prevent outbreaks of violence and ensure justice to all inmates. Steps have been taken via [] to remedy the above situation.

3. GACCESS, Isak Alla, Nexhip Kuka and Nazim Alla continually try to stir up dissatisfaction with HTNEIGH+the "Americans". ^{Also they} to agitate the inmates to quarrel amongst themselves.

4. On the 10th of June contact AICOCK passed on a complete list of movements of refugees to and from the camp together with their reason for so doing. Also transmitted by AICOCK was as much information as he was able to obtain on Muco Zenel (Cezme) who has been recommended by Malament as his representative at Lavrion and on Tahir Zera; AICOCK also submitted a list of the Malament supporters in Lavrion. All of the above information has been translated by Daytoper and given to [] .

5. Some of the pending assignments for AICOCK include interrogation of refugees to determine some of the ways in which peasants can resist the regime, and gathering of information for PW use.

6. AICOCK also notified [] that his immigration guarantee papers have arrived from Canada and that he hopes to leave for that country this year, sometime.
