Progress Report on Refat Hysen, Henije Hysen, and Ahmet Hyska
for the period 21 August through 7 September 1954

SUMMARY

1. Interrogations of Refat and Henije Hysen completed; subjects returned to Lavrica Camp 3 September 1954
2. Ahmet Hyska being presently handled by James P. Entler as a CE case.

Account of Developments

1. On 3 September 1954 supplementary and P/W interrogations of Refat and Henije Hysen were completed. Subsequently subjects were returned to Lavrica Camp. For all intents and purposes their cases are considered closed and no more reporting will be submitted to Headquarters on subjects. They conducted themselves well while under our responsibility and proved to be very co-operative throughout the interrogations.

2. As regards the case of Ahmet Hyska, subject had indicated on numerous occasions to [] and [] that he was ready and willing to work for Albania's cause under our auspices. This frequently repeated expression of subject's desire plus his intelligent and aggressive comportation motivated this desk to consider him for possible recruitment in the field of agent activity. On the basis of above, [] and [] interrogated subject on 3 September in preparation for LOFLUTTER. A number of discrepancies in his biography, however, became evident and it was recommended that subject be handled as a CE case and be given a thorough and meticulous interrogation prior to exposing subject to the LOFLUTTER and proceeding with further plans.

3. It should be noted that subject has lately changed his tune to some degree. He has become quite political in his attitude and approach, favoring very strongly the EKA Party of Abas Ermenje. During the interrogation of 3 September, subject indicated he was willing to accept agent activity assignment

on condition that the BKA representative be informed and gives approval to same. We have not given up on subject, but will await results of his interrogation. Depending upon the outcome of the Hyska's interrogation, it may be deemed necessary to interrogate other members of the Kamenice group. We will keep Headquarters advised of developments.

4. As of 4 September 1954, has taken responsibility for Ahmet Hyska.

5. A separate dispatch on USEP's publicity of the Kamenice Group is being forwarded to Headquarters.
