Action Requested: None. For Headquarters' information and files.

1. This is to inform you of the termination of AIRBRED, former FRIDAY Team member. Subject refused to go on the last mission with FRIDAY and as we have no foreseeable use for him in the future, it was decided to release him.
2. To the best of our knowledge, AIRBRED is not aware of the true identities of any American KUBARK personnel. Subject is aware of certain past CBOPUS operations from his participation in the FIGTREE and FRIDAY missions and through the publicity attending the Tirana trials.
3. Subject is being retained on the Greek Isle of Paros until he can be resettled and/or until it is felt he no longer constitutes a security risk. At present he is registered with WOC and USEP for emigration and his chances for emigrating to Australia are good.
4. To close Subject's file we are submitting herewith a copy of his agent service record. We are forwarding under separate cover a copy of his letter of termination.
