LOFLUTTER Test of RNDOLLAR, Case No. 2020, Test 2 and 3

REF: SGAA 13721, 21 January 1955

Action Requested: Charts and findings sent to

1. RNDOLLAR was interviewed 10 January 1955 and LOFLUTTER tested on the following day by The test was conducted in Albanian, interpreting.

2. Objects: To test the veracity of RNDOLLAR's July 1954 and December 1954 missions.

3. Procedure: Three sets of questions were run:

a. Set No. 1 consisted of norms.

b. Set No. 2 (two charts) consisted of questions pertaining to RNDOLLAR's July 1954 mission.

c. Set No. 3 (two charts) consisted of questions pertaining to RNDOLLAR's December 1954 mission.

d. A probable lie and a personal embarrassing questions were used as controls.

e. A card game was also run which indicated the card selected.

4. Analysis of the charts:

a. In set No. 2 specific responses were recorded on questions Nos. 8 and 12.

b. Both charts of set No. 3 were rendered illegible as a result of RNDOLLAR's repeated coughs. It should be noted, however, that RNDOLLAR really had a cold.

5. RNDOLLAR was not very cooperative. He displayed a very negative attitude during the interview and the test. RNDOLLAR explained that he felt hurt by the fact that doubted his statements about his July mission.

6. In order to make sure that no withholding of facts was hidden behind RNDOLLAR's negative attitude a second test on his July mission was conducted 14 January 1955. During this test RNDOLLAR was eager to cooperate as a result of his talk with

7. Analysis of the charts of the second test:

a. Specific responses were recorded on questions Nos. 8 and 11.

8. Results: The results of this test are favorable for RNDOLLAR with the exception of the question about RNDOLLAR's plans for a May contact with his brother. His reactions to these questions seem inconsistent with the development of his mission to date. We can not, therefore, deduce their significance at this time.

9. Estimated degree of reliability: RNDOLLAR is a fair reactor. The results of this test are therefore fairly accurate.

10. The charts and lists of questions of the two tests are being forwarded to Headquarters with the request that these be examined by the LOWLETTER personnel and their findings with the charts sent back to
