<b>a. <u>Action Reported by Field</u></b>							
<p>1. Field is examining two possible plans for re-mounting Wednesday Team. One plan consists of having the team return to the home of AILICH in order to make a second attempt to establish contact with him. If a direct approach fails, the team will then attempt to reach him through other potential contacts in the same town. If it is determined that it is not possible to contact AIPHIG directly or indirectly, the team will then proceed to the town of AINIBUS, second and most important target of the Wednesday Mission. The other plan is to have the team infiltrate at a point further south and proceed directly to the home of AINIBUS. Unless AIPHIG can be contacted (first plan) and used as a cut-out in contacting AINIBUS, 6 to 8 days will be required for the team to reach AINIBUS' home and return to Greece. This time factor necessitates the addition of another support agent (making a total of 3) for the Wednesday Team.</p> <p>2. Two of the agent standbys, AINIBUS and AINIBUS, will be temporarily transferred to the island of Tinos. The former has completely recovered from his previously reported stomach trouble.</p> <p>3. There are presently 8 agent standbys including members of the Wednesday Team.</p>
