SUBJECT: GENERAL— OBHUNT

SPECIFIC— Agent Standby Report for Period 1 - 29 February 1956

Ref: SGAA-19645, 1 March 1956

Action Requested: None; for Headquarters information and files.

1. There are seven OBHUNT agent stand-bys.

2. AIRWISE was met by [] several times during this last period. He continues in good health, and his desire to participate in one more mission has not diminished.

3. AICOOB has apparently heeded the advice we gave him last month as we have not had a single derogatory report concerning his activities. We have been unable to confirm the results of our preliminary investigation concerning AICOOB's role in the statements alleged to have been made by AIPOET against the Greeks. During one of the meetings with AICOOB, he assured [] he owed allegiance to no one except "the office," and took orders from no one except []

4. AIRBLOWN is still living in Piraeus with AICOOB. We are endeavoring to resettle AIRBLOWN as soon as possible as we do not foresee any operational use of him. There is a possibility he might be used to replace AIRLOCK at OBATLANTIS as W/T operator when AIRLOCK leaves Greece for resettlement.

5. AILICH and AIPUMP are still situated in Khalkis. Both men have been permitted to visit Athens separately during this last period. They are in good health and have managed to bear up under their long exile to Khalkis fairly well.

6. AIRSLACK was terminated by AUSBON on 17 February and departed for the United States on 19 February. AIRSLACK's agent service record, letter of termination and name and address of his sponsor were forwarded by SGAA-19659, 2 March 1956.

7. RNORDAIN, after AIRSLACK departed Greece, was returned to Athens and is now sharing quarters with AIRBORNE in a small house located in the outskirts of Athens.

8. AIRBORNE, a confirmed follower, becomes a problem when necessary to contact him or to give him instructions. Teaming him with RNORDAIN simplifies our handling of him and provides him with someone he can look to for leadership. By placing the men together now, we hope to determine if we might be able to use them as a team for some future operation.
